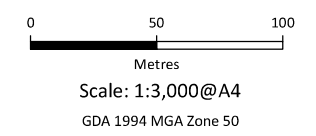

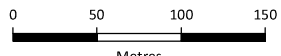

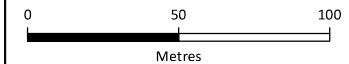

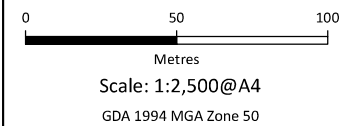

Figure 4: Plant Communities

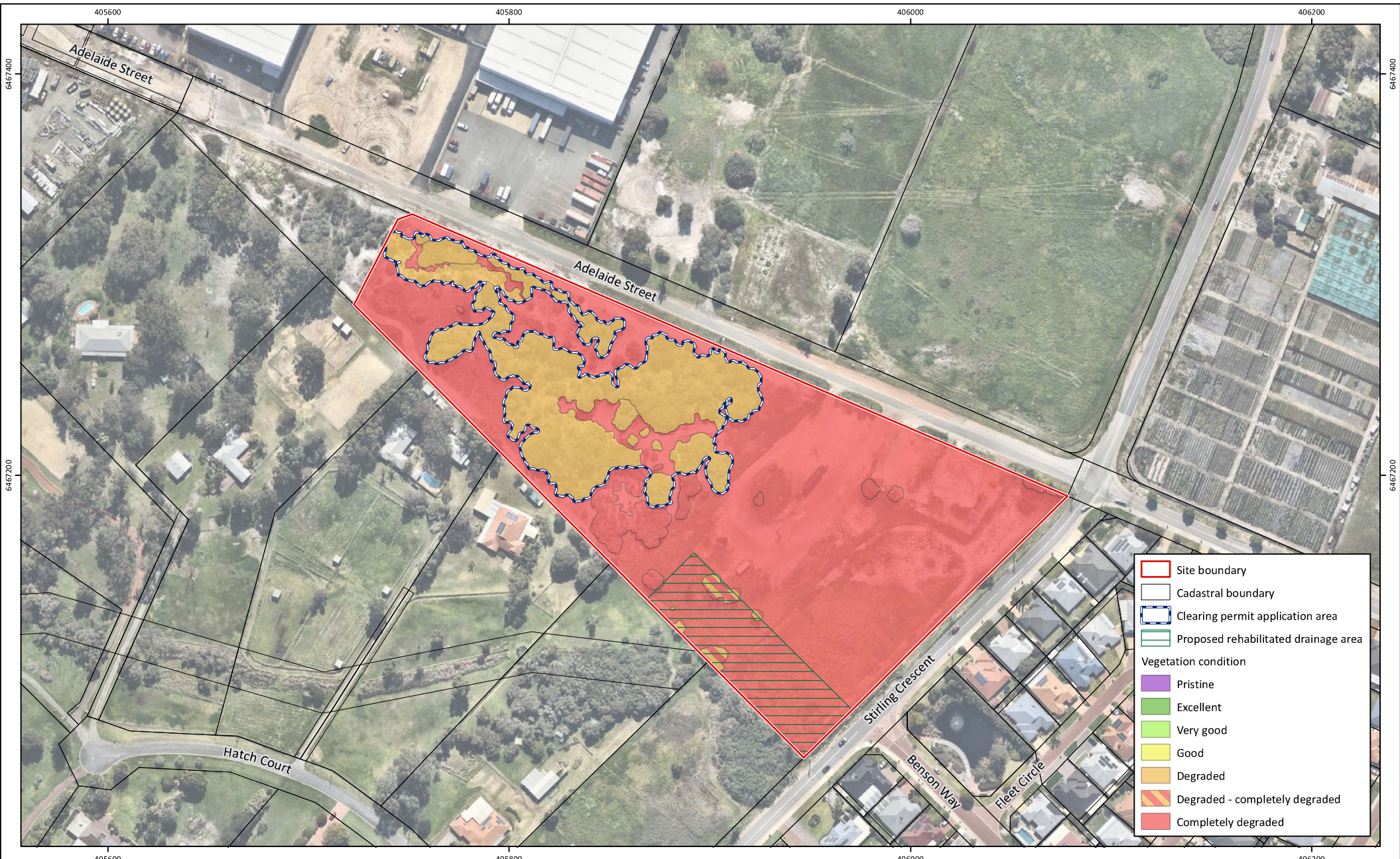

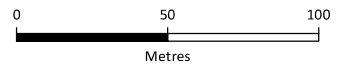

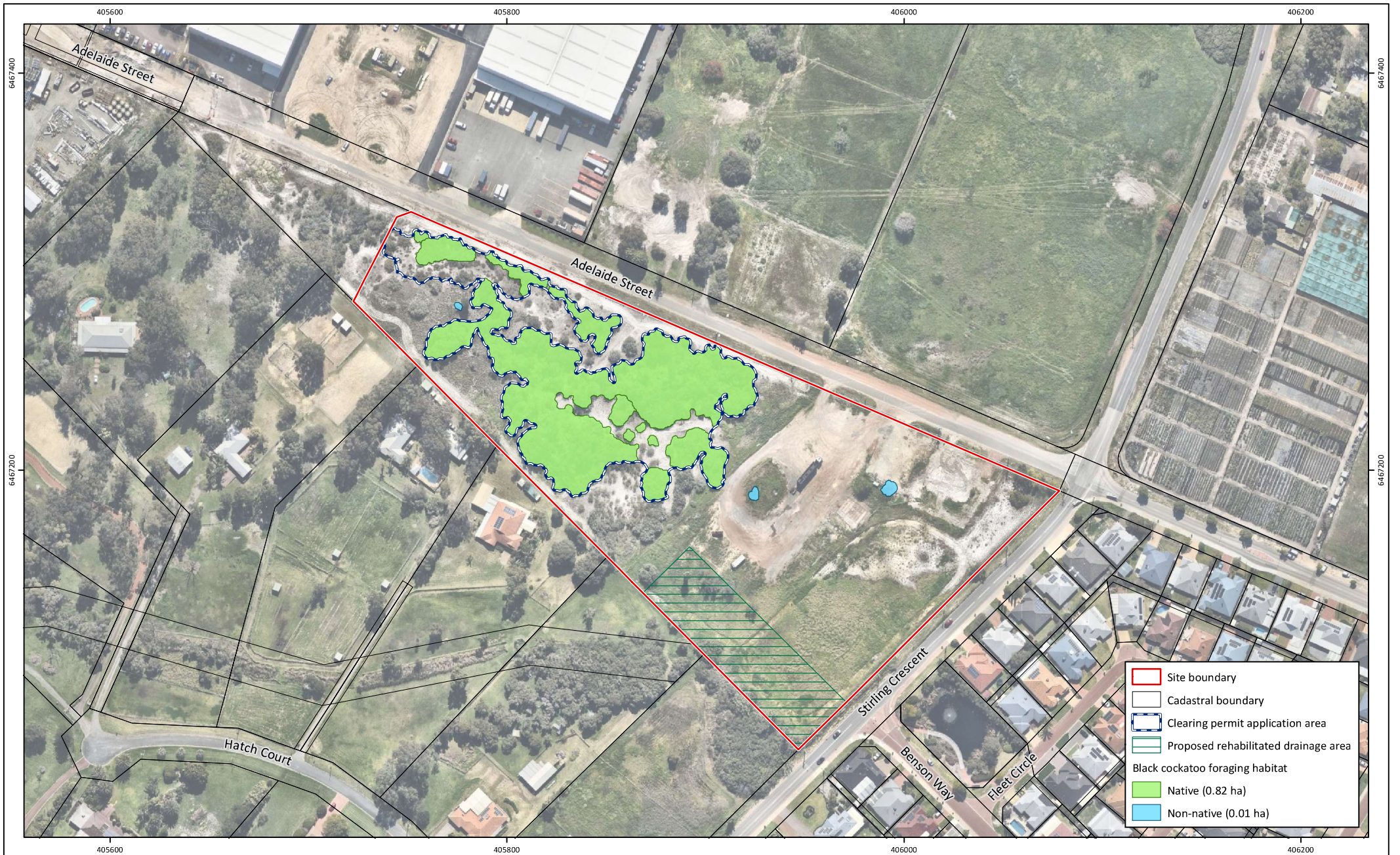

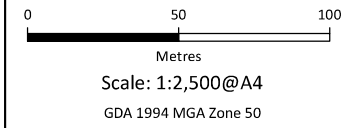

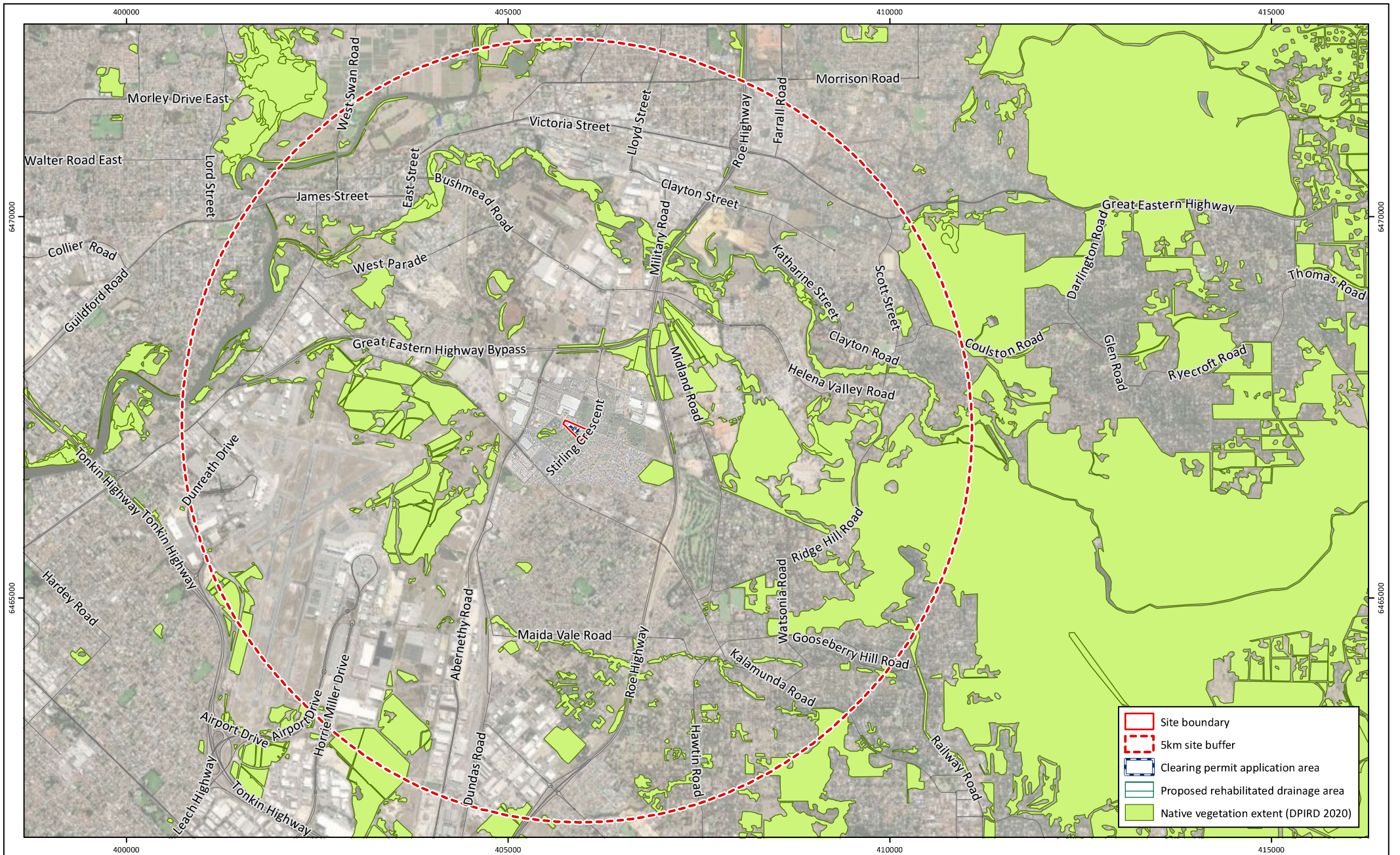


Figure 7: Local Native Vegetation Extent

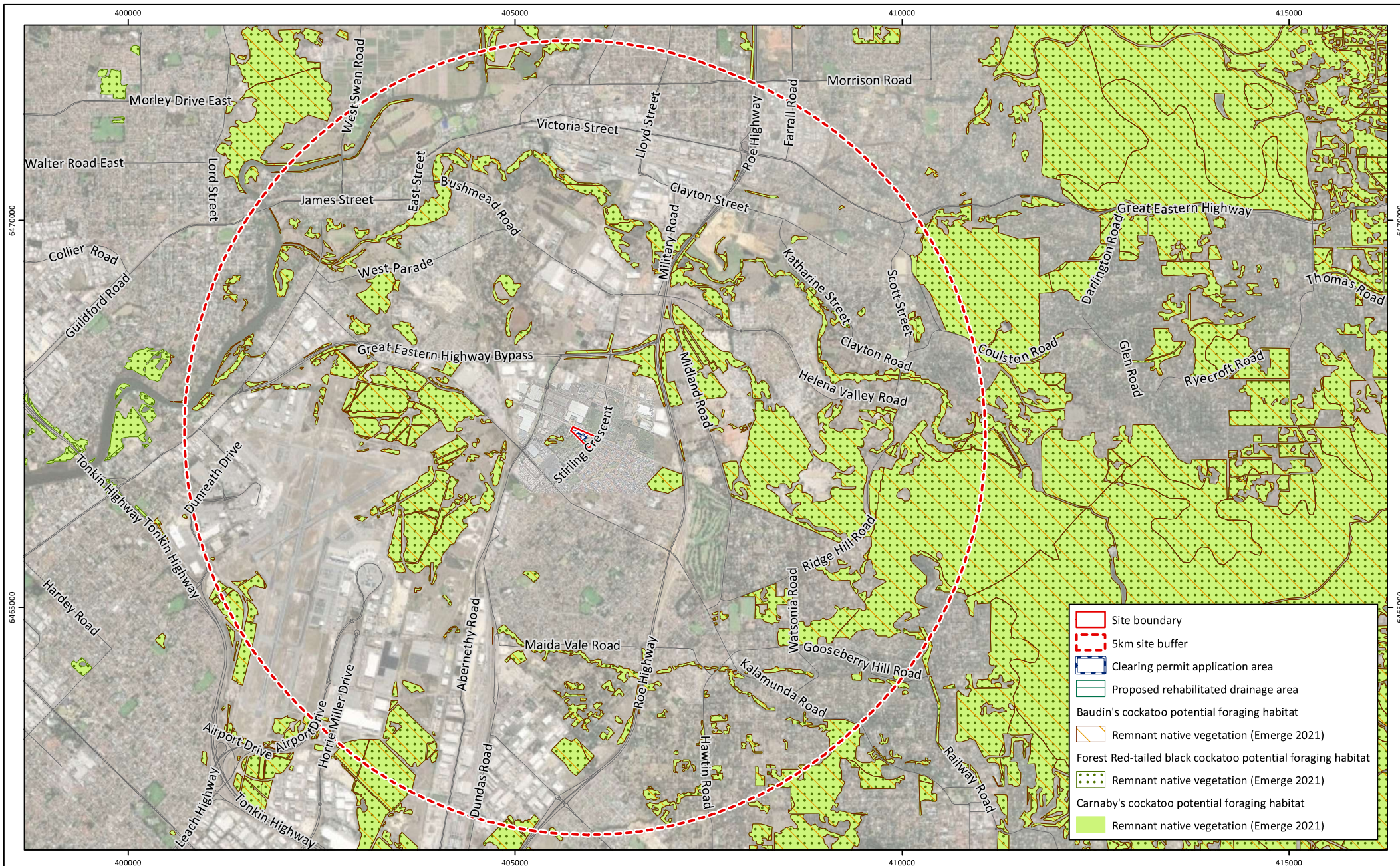


Figure 8: Black Cockatoo Habitat Extent
