I. Application details and outcomes

1.2. Description of clearing activities

Linden Gold Pty Ltd proposes to clear up to 20 hectares of native vegetation within a boundary of approximately 54 hectares, for the purpose of mineral production. The project is located approximately 119 kilometres southeast of Leonora, within the Shire of Menzies.

The application is to allow for the expansion of the existing Second Fortune Gold Mine.

1.4. Reasons for decision

This clearing permit application was made in accordance with section 51E of the *Environmental Protection Act 1986* (EP Act) and was received by the Department of Mines, Industry Regulation and Safety (DMIRS) on 31 March 2023. DMIRS advertised the application for a public comment for a period of 21 days, and no submissions were received.

In making this decision, the Delegated Officer had regard for the site characteristics (Appendix A), relevant datasets (Appendix D), the clearing principles set out in Schedule 5 of the EP Act (Appendix C), proposed avoidance and minimisation measures (Section 3.1), relevant planning instruments and any other matters considered relevant to the assessment (Section 3.3).

The assessment identified that the proposed clearing may result in:

 the potential introduction and spread of weeds into adjacent vegetation, which could impact on the quality of the adjacent vegetation and its habitat values.

After consideration of the available information, as well as the applicant's minimisation and mitigation measures (see Section 3.1), the Delegated Officer determined the proposed clearing can be minimised and managed to be unlikely to lead to an unacceptable risk to environmental values.

The Delegated Officer decided to grant a clearing permit subject to conditions to:

- avoid, minimise to reduce the impacts and extent of clearing; and
- take hygiene steps to minimise the risk of the introduction and spread of weeds.

2. Legislative context

The clearing of native vegetation in Western Australia is regulated under the EP Act and the Environmental Protection CPS 10145/1

(Clearing of Native Vegetation) Regulations 2004 (Clearing Regulations).

In addition to the matters considered in accordance with section 510 of the EP Act (see Section 1.4), the Delegated Officer has also had regard to the objects and principles under section 4A of the EP Act, particularly:

- the precautionary principle
- the principle of intergenerational equity
- the principle of the conservation of biological diversity and ecological integrity.

Other legislation of relevance for this assessment include:

- Biodiversity Conservation Act 2016 (WA) (BC Act)
- Conservation and Land Management Act 1984 (WA) (CALM Act)
- Mining Act 1978 (WA)

The key guidance documents which inform this assessment are:

3. Detailed assessment of application

3.1. Avoidance and mitigation measures

Environmental impacts are low enough not to require demonstration of avoidance and mitigation measures. However the applicant has advised that the mine expansion has been planned in previously disturbed area or adjacent to existing mine to minimise vegetation disturbance (Linden Gold, 2023).

The Delegated Officer was satisfied that the applicant has made a reasonable effort to avoid and minimise potential impacts of the proposed clearing on environmental values.

3.2. Assessment of impacts on environmental values

In assessing the application, the Delegated Officer has had regard for the site characteristics (see Appendix A) and the extent to which the impacts of the proposed clearing present a risk to biological, conservation, or land and water resource values.

The assessment against the clearing principles identified that the impacts of the proposed clearing present a risk to biological values (flora). The consideration of these impacts, and the extent to which they can be managed through conditions applied in line with sections 51H and 51I of the EP Act, is set out below.

3.2.1. Biological values (flora) - Clearing Principle (a)

Assessment

Botanica Consulting conducted a flora survey over the application area during October 2021. The EPA Technical Guidance for Flora and Vegetation Surveys for Environmental Impact Assessment (2016) stated that the appropriate time to conduct a flora survey in the Eremaean region from March through June. For this reason, the flora survey conducted by Botanica Consulting (2021), could have missed certain flora species that were not flowering during the time of the field survey. Priority 3 species *Calandrinia* sp. Menzies (F. Hort et al. FH 4100) was the only flora species that could potentially occur within the application area as the vegetation type and soil requirements for this species match the ones present in the application area (GIS Database). However, the long mining history of the Second Fortune Project has resulted in the area being highly disturbed (MBS Environmental, 2013; GIS Database). The lack of reinstated native vegetation cover in the proposed project area makes it highly unlikely that any conservation significant flora species would inhabit the area (MBS Environmental, 2013; GIS Database).

Conclusion

For the reasons set out above, it is considered that the impacts of the proposed clearing on conservation significant flora does not constitute a significant residual impact.

Conditions

No flora management conditions required.

3.3. Relevant planning instruments and other matters

The clearing permit application was advertised on 19 May 2023 by the Department of Mines, Industry Regulation and Safety inviting submissions from the public. No submissions were received in relation to this application.

There is one native title claim (WC2019/002) over the area under application (DPLH, 2023). This claim has been registered with the National Native Title Tribunal on behalf of the claimant group. However, the mining tenure has been granted in accordance with the future act regime of the *Native Title Act 1993* and the nature of the act (i.e. the proposed clearing activity) has been provided for in that process, therefore, the granting of a clearing permit is not a future act under the *Native Title Act 1993*.

There are no registered Aboriginal Sites of Significance within the application area (DPLH, 2023). It is the proponent's responsibility to comply with the *Aboriginal Heritage Act 1972* and ensure that no Aboriginal Sites of Significance are damaged through the clearing process.

Other relevant authorisations required for the proposed land use include:

• A Mining Proposal / Mine Closure Plan approved under the Mining Act 1978.

It is the proponent's responsibility to liaise with the Department of Water and Environmental Regulation and the Department of Biodiversity, Conservation and Attractions, to determine whether a Works Approval, Water Licence, Bed and Banks Permit, or any other licences or approvals are required for the proposed works.

A.1. Site ch	aracteristics
Characteristic	Details
Local context	The area proposed to be cleared is part of an expansive tract of native vegetation in the extensive land use zone of Western Australia. It is surrounded by native vegetation and it is adjacent to the existing Second Fortune Gold Mine (GIS Database). The dominant land uses of the Eastern Murchison subregion is grazing of native pastures (Botanica Consulting, 2021).
Ecological linkage	Aerial imagery shows the application area does not form part of any formal or informal ecological linkages (GIS Database).
Conservation areas	The application are is not located within any known or mapped conservation area. The closest mapped conservation area is Goongarrie National Park located approximately 90 kilometres northeast of the application area (GIS Database).
Vegetation description	The vegetation of the application area is broadly mapped as the following Beard vegetation association: 18: Mulga <i>Acacia aneura</i> and associated species (GIS Database).
	A flora and vegetation survey was conducted over the application area by Botanica Consulting during October 2021. The following vegetation communities were recorded within the application area (Botanica Consulting, 2021):
	RP-AS1 (Acacia sparse shrubland): Acacia incurvaneura, A. craspedocarpa and A. ramulosa sparse tall shrubland over Cratystylis subspinescens and Maireana sedifolia sparse shrubland over Ptilotus obovatus var. obovatus, Maireana georgei and M. trichoptera low sparse chenopod shrubland.
	CLP-AS1 (Acacia shrubland): Acacia incurvaneura, A. mulganeura and Casuarina pauper tall shrubland over Acacia tetragonophylla, Eremophila platycalyx and Senna artemisioides subsp. filifolia open shrubland over Ptilotus obovatus var. obovatus, Maireana triptera, M. georgei and Atriplex bunburyana low open shrubland.
Vegetation condition	The vegetation survey (Botanica Consulting, 2021) and aerial imagery indicate the vegetation within the proposed clearing area is in Good to Completely Degraded (Trudgen, 1991) condition.
	The full Trudgen (1991) condition rating scale is provided in Appendix C.
Climate and landform	The application area is located in an arid zone with an annual average rainfall (Leonora Station) of 236.4 millimetres (BoM, 2023).
Soil description	The soil within the application area is mapped as soil unit BE15 (GIS Database). Soil unit BE15 is described as gently undulating to low hilly pediments with stony and gravelly pavements, and traversed by numerous seasonal streams: chief soils seem to be shallow earthy loams with shallow red earths, both underlain by red-brown hardpan (Northcote et al., 1960-68).
Land degradation risk	The application area falls within the Gundockerta land system and the Rainbow land system (DPIRD, 2023). The Gundockerta land system is described as extensive, gently undulating, calcareous, stony plains, supporting bluebush shrublands. Where not protected by a stony mantle, saline plains and adjacent lower alluvial tracts are susceptible to water erosion, particularly in areas where perennial shrub cover is substantially reduced or the soil surface is disturbed (Pringle et al., 1994). The Rainbow land system is described as hardpan plains supporting mulga shrublands. This system is generally not susceptible to soil erosion, although impedance of sheet flow can initiate soil erosion (Pringle et al., 1994).
Waterbodies	The desktop assessment and aerial imagery indicated that no watercourses transect the area proposed to be cleared (GIS Database).
Hydrogeography	The application area falls within the Goldfields Groundwater Area, which is legislated by the <i>RIWI Act 1914</i> (GIS Database). The mapped groundwater salinity is 3,000-7,000 milligrams per litre total dissolved solids which is described as brackish to saline (GIS Database).
Flora	No Threatened or Priority flora species were recorded within the application area (Botanica Consulting, 2021; GIS Database).
Ecological communities	The application area is not located within a known or mapped Threatened Ecological Communities or Priority Ecological Communities (GIS Database). The closest record to the application area is the Priority 3 Mount Linden Range vegetation complex (banded ironstone formation) PEC (GIS Database).
Fauna	There are no records of conservation significant fauna within the application area (MBS Environmental, 2013; GIS Database).

Although Mount Linden Range vegetation complex (banded ironstone formation) PEC (P3) is located approximately 2.3 kilometres north of the application area (GIS Database), none of the vegetation communities recorded within the application area correspond to the PEC (Botanica Consulting, 2021). Three weed species were recorded within the application area. None of the recorded weed species are listed as Weeds of National Significance or Declared Pests (Botanica Consulting, 2021). Weeds have the potential to significantly change the dynamics of a natural ecosystem and lower the biodiversity of an area. Potential impacts to the biodiversity as a result of the proposed clearing may be minimised by the implementation of a weed management condition.

There are no records of conservation significant fauna within the application area or within a 20 kilometre radius (GIS Database). The long mining history of the Second Fortune Project has resulted in the area being highly disturbed (MBS Environmental, 2013; GIS Database). The lack of reinstated native vegetation cover in the proposed project area makes it highly unlikely that any conservation significant fauna species would inhabit the area, or that development of this area, if occurring on areas of existing disturbance, would threaten any fauna species with the potential to occur within the application area (MBS Environmental, 2013).

No Threatened flora species have been recorded within the application area (Botanica Consulting, 2021; GIS Database).

The application area falls within the Murchison Bioregion of the Interim Biogeographic Regionalisation for Australia (GIS Database). Over 99 per cent of the pre-European vegetation still exists in the Murchison Bioregion (Government of Western Australia, 2019). The application area is broadly mapped as Beard vegetation association 18 (GIS Database), This vegetation association has not been extensively cleared as over 99 per cent of the pre-European extent of these vegetation association remain uncleared at both the state and bioregional level (Government of Western Australia, 2019).

Appendix C. Vegetation condition rating scale

Vegetation condition is a rating given to a defined area of vegetation to categorise and rank disturbance related to human activities. The rating refers to the degree of change in the vegetation structure, density and species present in relation to undisturbed vegetation of the same type. The degree of disturbance impacts upon the vegetation's ability to regenerate. Disturbance at a site can be a cumulative effect from a number of interacting disturbance types.

Considering its location, the scale below was used to measure the condition of the vegetation proposed to be cleared. This scale has been extracted from Trudgen, M.E. (1991) *Vegetation condition scale* in National Trust (WA) 1993 Urban Bushland Policy. National Trust of Australia (WA), Wildflower Society of WA (Inc.), and the Tree Society (Inc.), Perth.

Measuring vegetation condition for the Eremaean and Northern Botanical Provinces (Trudgen, 1991)

Condition	Description
Excellent	Pristine or nearly so, no obvious signs of damage caused by human activities since European settlement.
Very good	Some relatively slight signs of damage caused by human activities since European settlement. For example, some signs of damage to tree trunks caused by repeated fire, the presence of some relatively non-aggressive weeds, or occasional vehicle tracks.
Good	More obvious signs of damage caused by human activity since European settlement, including some obvious impact on the vegetation structure such as that caused by low levels of grazing or slightly aggressive weeds.
Poor	Still retains basic vegetation structure or ability to regenerate it after very obvious impacts of human activities since European settlement, such as grazing, partial clearing, frequent fires or aggressive weeds.
Very poor	Severely impacted by grazing, very frequent fires, clearing or a combination of these activities. Scope for some regeneration but not to a state approaching good condition without intensive management. Usually with a number of weed species present including very aggressive species.
Completely degraded	Areas that are completely or almost completely without native species in the structure of their vegetation; i.e. areas that are cleared or 'parkland cleared' with their flora comprising weed or crop species with isolated native trees or shrubs.

Definitions:

{DBCA (2019) Conservation Codes for Western Australian Flora and Fauna. Department of Biodiversity, Conservation and Attractions, Western Australia}:-

T <u>Threatened species:</u>

Listed by order of the Minister as Threatened in the category of critically endangered, endangered or vulnerable under section 19(1), or is a rediscovered species to be regarded as threatened species under section 26(2) of the *Biodiversity Conservation Act 2016* (BC Act).

Threatened fauna is that subset of 'Specially Protected Fauna' listed under schedules 1 to 3 of the *Wildlife Conservation (Specially Protected Fauna) Notice 2018* for Threatened Fauna.

Threatened flora is that subset of 'Rare Flora' listed under schedules 1 to 3 of the Wildlife Conservation (Rare Flora) Notice 2018 for Threatened Flora.

The assessment of the conservation status of these species is based on their national extent and ranked according to their level of threat using IUCN Red List categories and criteria as detailed below.

CR Critically endangered species

Threatened species considered to be "facing an extremely high risk of extinction in the wild in the immediate future, as determined in accordance with criteria set out in the ministerial guidelines".

Listed as critically endangered under section 19(1)(a) of the BC Act in accordance with the criteria set out in section 20 and the ministerial guidelines. Published under schedule 1 of the *Wildlife Conservation (Specially Protected Fauna) Notice 2018* for critically endangered fauna or the *Wildlife Conservation (Rare Flora) Notice 2018* for critically endangered flora.

EN Endangered species

Threatened species considered to be "facing a very high risk of extinction in the wild in the near future, as determined in accordance with criteria set out in the ministerial guidelines".

Listed as endangered under section 19(1)(b) of the BC Act in accordance with the criteria set out in section 21 and the ministerial guidelines. Published under schedule 2 of the *Wildlife Conservation* (Specially Protected Fauna) Notice 2018 for endangered fauna or the *Wildlife Conservation* (Rare Flora) Notice 2018 for endangered flora.

VU Vulnerable species

Threatened species considered to be "facing a high risk of extinction in the wild in the medium-term future, as determined in accordance with criteria set out in the ministerial guidelines".

Listed as vulnerable under section 19(1)(c) of the BC Act in accordance with the criteria set out in section 22 and the ministerial guidelines. Published under schedule 3 of the *Wildlife Conservation* (Specially Protected Fauna) Notice 2018 for vulnerable fauna or the *Wildlife Conservation* (Rare Flora) Notice 2018 for vulnerable flora.

Extinct Species:

Extinct species

EX

Species where "there is no reasonable doubt that the last member of the species has died", and listing is otherwise in accordance with the ministerial guidelines (section 24 of the BC Act).

Published as presumed extinct under schedule 4 of the *Wildlife Conservation (Specially Protected Fauna) Notice 2018* for extinct fauna or the *Wildlife Conservation (Rare Flora) Notice 2018* for extinct flora.

EW Extinct in the wild species

Species that "is known only to survive in cultivation, in captivity or as a naturalised population well outside its past range; and it has not been recorded in its known habitat or expected habitat, at appropriate seasons, anywhere in its past range, despite surveys over a time frame appropriate to its life cycle and form", and listing is otherwise in accordance with the ministerial guidelines (section 25 of the BC Act).

Currently there are no threatened fauna or threatened flora species listed as extinct in the wild. If listing of a species as extinct in the wild occurs, then a schedule will be added to the applicable notice.

Specially protected species:

Listed by order of the Minister as specially protected under section 13(1) of the BC Act. Meeting one or more of the following categories: species of special conservation interest; migratory species; cetaceans; species subject to international agreement; or species otherwise in need of special protection.

Species that are listed as threatened species (critically endangered, endangered or vulnerable) or extinct species under the BC Act cannot also be listed as Specially Protected species.

MI Migratory species

Fauna that periodically or occasionally visit Australia or an external Territory or the exclusive economic zone; or the species is subject of an international agreement that relates to the protection of migratory species and that binds the Commonwealth; and listing is otherwise in accordance with the ministerial guidelines (section 15 of the BC Act).

Includes birds that are subject to an agreement between the government of Australia and the governments of Japan (JAMBA), China (CAMBA) and The Republic of Korea (ROKAMBA), and fauna subject to the *Convention on the Conservation of Migratory Species of Wild Animals* (Bonn Convention), an environmental treaty under the United Nations Environment Program. Migratory species listed under the BC Act are a subset of the migratory animals, that are known to visit Western Australia, protected under the international agreements or treaties, excluding species that are listed as Threatened species.

Published as migratory birds protected under an international agreement under schedule 5 of the *Wildlife Conservation (Specially Protected Fauna) Notice 2018.*

CD Species of special conservation interest (conservation dependent fauna)

Fauna of special conservation need being species dependent on ongoing conservation intervention to prevent it becoming eligible for listing as threatened, and listing is otherwise in accordance with the ministerial guidelines (section 14 of the BC Act).

Published as conservation dependent fauna under schedule 6 of the *Wildlife Conservation (Specially Protected Fauna) Notice 2018.*

OS Other specially protected species

Fauna otherwise in need of special protection to ensure their conservation, and listing is otherwise in accordance with the ministerial guidelines (section 18 of the BC Act).

Published as other specially protected fauna under schedule 7 of the *Wildlife Conservation (Specially Protected Fauna) Notice 2018.*

P <u>Priority species:</u>

Possibly threatened species that do not meet survey criteria, or are otherwise data deficient, are added to the Priority Fauna or Priority Flora Lists under Priorities 1, 2 or 3. These three categories are ranked in order of priority for survey and evaluation of conservation status so that consideration can be given to their declaration as threatened fauna or flora.

Species that are adequately known, are rare but not threatened, or meet criteria for near threatened, or that have been recently removed from the threatened species or other specially protected fauna lists for other than taxonomic reasons, are placed in Priority 4. These species require regular monitoring.

Assessment of Priority codes is based on the Western Australian distribution of the species, unless the distribution in WA is part of a contiguous population extending into adjacent States, as defined by the known spread of locations.

P1 Priority One - Poorly-known species

Species that are known from one or a few locations (generally five or less) which are potentially at risk. All occurrences are either: very small; or on lands not managed for conservation, e.g. agricultural or pastoral lands, urban areas, road and rail reserves, gravel reserves and active mineral leases; or otherwise under threat of habitat destruction or degradation. Species may be included if they are comparatively well known from one or more locations but do not meet adequacy of survey requirements and appear to be under immediate threat from known threatening processes. Such species are in urgent need of further survey.

P2 Priority Two - Poorly-known species

Species that are known from one or a few locations (generally five or less), some of which are on lands managed primarily for nature conservation, e.g. national parks, conservation parks, nature reserves and other lands with secure tenure being managed for conservation. Species may be included if they are comparatively well known from one or more locations but do not meet adequacy of survey requirements and appear to be under threat from known threatening processes. Such species are in urgent need of further survey.

P3 Priority Three - Poorly-known species

Species that are known from several locations, and the species does not appear to be under imminent threat, or from few but widespread locations with either large population size or significant remaining areas of apparently suitable habitat, much of it not under imminent threat. Species may be included if they are comparatively well known from several locations but do not meet adequacy of survey requirements and known threatening processes exist that could affect them. Such species are in need of further survey.

P4 Priority Four - Rare, Near Threatened and other species in need of monitoring

(a) Rare. Species that are considered to have been adequately surveyed, or for which sufficient knowledge is available, and that are considered not currently threatened or in need of special protection but could be if present circumstances change. These species are usually represented on conservation lands.

(b) Near Threatened. Species that are considered to have been adequately surveyed and that are close to qualifying for vulnerable but are not listed as Conservation Dependent.

(c) Species that have been removed from the list of threatened species during the past five years for reasons other than taxonomy.

Principles for clearing native vegetation:

- (a) Native vegetation should not be cleared if it comprises a high level of biological diversity.
- (b) Native vegetation should not be cleared if it comprises the whole or a part of, or is necessary for the maintenance of, a significant habitat for fauna.
- (c) Native vegetation should not be cleared if it includes, or is necessary for the continued existence of, threatened flora.
- (d) Native vegetation should not be cleared if it comprises the whole or a part of, or is necessary for the maintenance of a threatened ecological community.
- (e) Native vegetation should not be cleared if it is significant as a remnant of native vegetation in an area that has been extensively cleared.
- (f) Native vegetation should not be cleared if it is growing in, or in association with, an environment associated with a watercourse or wetland.
- (g) Native vegetation should not be cleared if the clearing of the vegetation is likely to cause appreciable land degradation.
- (h) Native vegetation should not be cleared if the clearing of the vegetation is likely to have an impact on the environmental values of any adjacent or nearby conservation area.
- (i) Native vegetation should not be cleared if the clearing of the vegetation is likely to cause deterioration in the quality of surface or underground water.
- (j) Native vegetation should not be cleared if the clearing of the vegetation is likely to cause, or exacerbate, the incidence or intensity of flooding.
