

## **CLEARING PERMIT**

Granted under section 51E of the Environmental Protection Act 1986

**Purpose Permit number:** 10167/1

**Duration of Permit:** From 20 July 2023 to 19 July 2028

Permit Holder: Fortescue Metals Group Ltd

The Permit Holder is authorised to clear native vegetation subject to the following conditions of this Permit.

## PART I - CLEARING AUTHORISED

### 1. Land on which clearing is to be done

Mining Lease 45/1226

#### 2. Clearing authorised (purpose)

The Permit Holder is authorised to clear native vegetation for the purpose of mineral exploration.

#### 3. Area of Clearing




Figure 1: Map of the boundary of the area within which clearing may occur.

The Permit Holder must not clear more than 4.75 hectares of native vegetation within the area cross-hatched yellow in Figure 1 of Schedule 1.

## 4. Directional clearing

The Permit Holder shall must:

- (a) conduct all clearing authorised under this permit in one direction towards adjacent vegetation; and
- (b) allow a reasonable time for fauna present within the area being cleared to move into that adjacent native vegetation ahead of the clearing activity.

## **PART II - MANAGEMENT CONDITIONS**

### 5. Avoid, minimise and reduce the impacts and extent of clearing

In determining the amount of native vegetation to be cleared under this Permit, the Permit Holder must apply the following principles, set out in descending order of preference:

- (a) avoid the clearing of native vegetation;
- (b) minimise the amount of native vegetation to be cleared; and
- (c) reduce the impact of clearing on any environmental value.

#### 6. Weed control

When undertaking any clearing or other activity authorised under this Permit, the Permit Holder must take the following steps to minimise the risk of the introduction and spread of *weeds*:

- (a) clean earth-moving machinery of soil and vegetation prior to entering and leaving the area to be cleared;
- (b) ensure that no known or weed-affected soil, mulch, fill or other material is brought into the area to be cleared; and
- (c) restrict the movement of machines and other vehicles to the limits of the areas to be cleared.

### 7. Flora Management

Where *threatened flora* species *Quoya zonalis* has been identified and the written locations provided in the 'locations of *Quoya zonalis* shapefile' and retained on the Department of Mines, Industry Regulation and Safety file 'A0497/202301', Doc ID '10247664' the Permit Holder shall ensure that:

- (i) no clearing of identified threatened flora occurs, unless first approved by the CEO; and
- (ii) no clearing occurs within 50 metres of threatened flora, unless first approved by the CEO.

## PART III - RECORD KEEPING AND REPORTING

#### 8. Records to be kept

The Permit Holder must maintain records relating to the listed relevant matters in accordance with the specifications detailed in Table 1.

Table 1: Records that must be kept

No.	Relevant matter	Specifications
1.	In relation to the authorised clearing activities generally	(a) the location where the clearing occurred, recorded using a Global Positioning System (GPS) unit set to Geocentric Datum Australia 1994 (GDA94), expressing the geographical coordinates in Eastings and Northings;
		(b) the date that the area was cleared;
		(c) the size of the area cleared (in hectares);
		(d) actions taken to avoid, minimise, and reduce the impacts and extent of clearing in accordance with Condition 5; and
		(e) actions taken to minimise the risk of the introduction and spread of <i>weeds</i> and in accordance with Condition 6.
2.	In relation to flora management pursuant to Condition 7	(a) the name and location of each <i>threatened flora</i> species, recorded using a Global Positioning System (GPS) unit set to Geocentric Datum Australia 1994 (GDA94), expressing the geographical coordinates in Eastings and Northings;
		(b) actions taken to demarcate each <i>threatened flora</i> species recorded and their relevant buffers; and
		(c) actions taken to avoid the clearing of <i>threatened flora</i> species.

## 9. Reporting

- (a) The Permit Holder shall provide a report to the *CEO* by 31 July each year for the life of this Permit, demonstrating adherence to all conditions of this Permit, and setting out the records required under Condition 8 of this Permit in relation to clearing carried out between 1 July and 30 June of the previous financial year.
- (b) If no clearing authorised under this Permit was undertaken between 1 July and 30 June of the previous financial year, a written report confirming that no clearing under this permit has been carried out, must be provided to the *CEO* by 31 July of each year.
- (c) Prior to 19 July 2028, the Permit Holder must provide to the *CEO* a written report of records required under Condition 6 of this Permit where these records have not already been provided under Condition 9(a) or 9(b) of this Permit.

## **DEFINITIONS**

In this Permit, the terms in Table 2 have the meanings defined.

**Table 2: Definitions** 

Term	Definition	
CEO	the Chief Executive Officer of the Department responsible for administering the clearing provisions contained within the <i>Environmental Protection Act 1986</i> or an Officer with delegated authority under Section 20 of the <i>Environmental Protection Act 1986</i> .	
clearing	has the meaning given under section 3(1) of the EP Act.	
condition/s	a condition to which this clearing permit is subject under section 51H of the EP Act.	
department	means the department established under section 35 of the <i>Public Sector Management Act 1994</i> (WA) and designated as responsible for the administration of the EP Act, which includes Part V Division 3.	
EP Act	Environmental Protection Act 1986 (WA)	
fill	means material used to increase the ground level, or to fill a depression.	
mulch	means the use of organic matter, wood chips or rocks to slow the movement of water across the soil surface and to reduce evaporation.	
native vegetation	has the meaning given under section 3(1) and section 51A of the EP Act.	
threatened flora	means those plant taxa listed as threatened flora under the <i>Biodiversity Conservation Act 2016</i> .	
weed/s	means any plant —  (a) that is a declared pest under section 22 of the <i>Biosecurity and Agriculture Management Act 2007</i> ; or  (b) published in a Department of Biodiversity, Conservation and Attractions species-led ecological impact and invasiveness ranking summary, regardless of ranking; or  (c) not indigenous to the area concerned.

The boundary of the area authorised to be cleared is shown in the map below (Figure 1).
