

CLEARING PERMIT

Granted under section 51E of the Environmental Protection Act 1986

Purpose Permit number: 10242/1

Duration of Permit: From 9 September 2023 to 8 September 2028

Permit Holder: Northern Star Resources Limited

The Permit Holder is authorised to clear native vegetation subject to the following conditions of this Permit.

PART I - CLEARING AUTHORISED

1. Land on which clearing is to be done

2. Clearing authorised (purpose)

The Permit Holder is authorised to clear native vegetation for the purpose of mineral production and associated activities.

3. Area of Clearing




Figure 1: Map of the boundary of the area within which clearing may occur

The Permit Holder must not clear more than 350 hectares of native vegetation within the area cross-hatched yellow in Figure 1 of Schedule 1.

4. Type of Clearing Authorised – staged clearing

The Permit Holder shall not clear native vegetation unless mineral production and associated activities commences within six months of the authorised clearing being undertaken.

5. Directional clearing

The Permit Holder shall must:

- (a) conduct all clearing authorised under this permit in one direction towards adjacent vegetation; and
- (b) allow a reasonable time for fauna present within the area being cleared to move into that adjacent native vegetation ahead of the clearing activity.

PART II - MANAGEMENT CONDITIONS

6. Avoid, minimise and reduce the impacts and extent of clearing

In determining the amount of native vegetation to be cleared under this Permit, the Permit Holder must apply the following principles, set out in descending order of preference:

- (a) avoid the clearing of native vegetation;
- (b) minimise the amount of native vegetation to be cleared; and

(c) reduce the impact of clearing on any environmental value.

7. Weed control

When undertaking any clearing or other activity authorised under this Permit, the Permit Holder must take the following steps to minimise the risk of the introduction and spread of *weeds*:

- (a) clean earth-moving machinery of soil and vegetation prior to entering and leaving the area to be cleared;
- (b) ensure that no known or *weed*-affected soil, *mulch*, *fill* or other material is brought into the area to be cleared; and
- (c) restrict the movement of machines and other vehicles to the limits of the areas to be cleared.

PART III - RECORD KEEPING AND REPORTING

8. Records to be kept

The Permit Holder must maintain records relating to the listed relevant matters in accordance with the specifications detailed in Table 1.

Table 1: Records that must be kept

1.	In relation to the authorised clearing activities generally	(a)	the location where the clearing occurred, recorded using a Global Positioning System (GPS) unit set to Geocentric Datum Australia 1994 (GDA94), expressing the geographical coordinates in Eastings and Northings;

		(c)	the size of the area cleared (in hectares);
		(d)	actions taken to avoid, minimise, and reduce the impacts and extent of clearing in accordance with Condition 6; and
		(e)	actions taken to minimise the risk of the introduction and spread of <i>weeds</i> in accordance with Condition 7; and
		(f)	actions taken in accordance with Condition 4 and 5.

9. Reporting

- (a) The Permit Holder shall provide a report to the *CEO* by 31 July each year for the life of this Permit, demonstrating adherence to all conditions of this Permit, and setting out the records required under Condition 8 of this Permit in relation to clearing carried out between 30 June and 1 July of the previous financial year.
- (b) If no clearing authorised under this Permit was undertaken between 30 June and 1 July of the previous financial year, a written report confirming that no clearing under this permit has been carried out, must be provided to the *CEO* by 31 July of each year.
- (c) Prior to 8 September 2028, the Permit Holder must provide to the *CEO* a written report of records required under Condition 8 of this Permit where these records have not already been provided under Condition 9(a) or 9(b) of this Permit.

DEFINITIONS

In this Permit, the terms in Table 2 have the meanings defined.

The boundary of the area authorised to be cleared is shown in the map below (Figure 1).
