

# **Clearing Permit Decision Report**

# 1. Application details and outcomes

## 1.1. Permit application details

## 1.2. Description of clearing activities

AWE Perth Pty Ltd proposes to clear up to 0.3205 hectares of native vegetation within a boundary of approximately 0.3205 hectares, for the purpose of decommissioning a well. The project is located approximately 9.7 kilometres northwest of Port Denison, within the Shire of Irwin.

The application is to allow for clearing of regrowth vegetation (over 10 years old) for the rig package to assist in decommisioning (plug and abandonment of the well).

# 1.3. Decision on application and key considerations

Decision: Grant

**Decision date:** 21 December 2023

**Decision area:** 0.3205 hectares of native vegetation

# 1.4. Reasons for decision

This clearing permit application was made in accordance with section 51E of the *Environmental Protection Act 1986* (EP Act) and was received by the Department of Mines, Industry Regulation and Safety (now Department of Energy, Mines, Industry Regulation and Safety (DEMIRS)) on 20 November 2023. DEMIRS advertised the application for a public comment for a period of 21 days, and no submissions were received.

In making this decision, the Delegated Officer had regard for the site characteristics (Appendix A), relevant datasets (Appendix D), the clearing principles set out in Schedule 5 of the EP Act (Appendix C), proposed avoidance and minimisation measures (Section 3.1), relevant planning instruments and any other matters considered relevant to the assessment (Section 3.3).

The assessment identified that the proposed clearing may result in:

• the potential introduction and spread of weeds into adjacent vegetation, which could impact on the quality of the adjacent vegetation and its habitat values.

After consideration of the available information, as well as the applicant's minimisation and mitigation measures (see Section 3.1), the Delegated Officer determined the proposed clearing can be minimised and managed to be unlikely to lead to an unacceptable risk to environmental values.

The Delegated Officer decided to grant a clearing permit subject to conditions to:

- avoid, minimise to reduce the impacts and extent of clearing; and
- take hygiene steps to minimise the risk of the introduction and spread of weeds.

# 1.5. Site map

A site map of proposed clearing is provided in Figure 1 below.



Figure 1. Map of the application area. The yellow area indicates the area within which conditional authorised clearing can occur under the granted clearing permit.

# 2. Legislative context

The clearing of native vegetation in Western Australia is regulated under the EP Act and the Environmental Protection (Clearing of Native Vegetation) Regulations 2004 (Clearing Regulations).

In addition to the matters considered in accordance with section 51O of the EP Act (see Section 1.4), the Delegated Officer has also had regard to the objects and principles under section 4A of the EP Act, particularly:

- the precautionary principle
- the principle of intergenerational equity
- the principle of the conservation of biological diversity and ecological integrity.

Other legislation of relevance for this assessment include:

Biodiversity Conservation Act 2016 (WA) (BC Act)

- Conservation and Land Management Act 1984 (WA) (CALM Act)
- The Petroleum and Geothermal Energy Resources Act 1967 (WA)

The key guidance documents which inform this assessment are:

- Procedure: Native vegetation clearing permits (DWER, October 2021)

# 3. Detailed assessment of application

# 3.1. Avoidance and mitigation measures

No evidence of avoidance or mitigation measures was provided to support the application. While no evidence of avoidance or mitigation measures was provided to support the application, noting the low impact and small scale of the proposed clearing it was deemed that no further consideration is required to minimise impacts on environmental values.

# 3.2. Assessment of impacts on environmental values

In assessing the application, the Delegated Officer has had regard for the site characteristics (see Appendix A) and the extent to which the impacts of the proposed clearing present a risk to biological, conservation, or land and water resource values.

The assessment against the clearing principles (see Appendix B) identified the impacts of the proposed clearing are limited and able to be managed to be environmentally acceptable with standard avoid and minimize, rehabilitation and hygiene management conditions.

# 3.3. Relevant planning instruments and other matters

The clearing permit application was advertised on 28 November 2023 by the Department of Mines, Industry Regulation and Safety inviting submissions from the public. No submissions were received in relation to this application.

There is one native title claim (WCD 2020/001) over the area under application (DPLH, 2023). This claim has been determined by the Federal Court on behalf of the claimant group (Yamatji). However, the mining tenure has been granted in accordance with the future act regime of the *Native Title Act 1993* and the nature of the act (i.e. the proposed clearing activity) has been provided for in that process, therefore, the granting of a clearing permit is not a future act under the *Native Title Act 1993*.

There are no registered Aboriginal Sites of Significance within the application area (DPLH, 2023). It is the proponent's responsibility to comply with the *Aboriginal Heritage Act 1972* and ensure that no Aboriginal Sites of Significance are damaged through the clearing process.

Other relevant authorisations required for the proposed land use include:

An Environment Plan approved under the Petroleum and Geothermal Energy Resources Act 1967

It is the proponent's responsibility to liaise with the Department of Water and Environmental Regulation and the Department of Biodiversity, Conservation and Attractions, to determine whether a Works Approval, Water Licence, Bed and Banks Permit, or any other licences or approvals are required for the proposed works.

# Appendix A. Site characteristics

# A.1. Site characteristics

Characteristic	Details
Local context	The area proposed to be cleared consists of two isolated patches (0.45 hectares and 40 hectares) of native vegetation in the intensive land use zone of Western Australia. It is surrounded by isolated patches of native vegetation and it is located near Brand Highway (GIS Database).
Ecological linkage	According to aerial imagery, the application area does not form part of any formal or informal ecological linkages (GIS Database).
Conservation areas	The application area is not located within any known or mapped conservation areas. The closest mapped conservation area is the Yardanogo Nature Reserve located 3.4 kilometres southeast of the application area (GIS Database).
Vegetation description	The vegetation of the application area is broadly mapped as the following Beard vegetation association: 433: Low woodland/Scrub (GIS Database).
Vegetation condition	Aerial imagery indicates the vegetation within the proposed clearing area is in Good (Keighery, 1994) condition.  The full Keighery (1994) condition rating scale is provided in Appendix C.
Climate and landform	The application area is located in a winter dormant zone with marked wet winter and dry summer and an average annual rainfall (Port Denison Station) of 400 millimetres (BoM, 2023).
Soil description	The soil within the application area is mapped as soil unit B24 (GIS Database). This soil unit is described as undulating dune landscape underlain by aeolianite which is frequently exposed; small swales of estuarine deposits are included: chief soils are siliceous sands with smaller areas of brown sands and leached sands in the wetter sites (Northcote et al., 1960-68).
Land degradation risk	The application area falls within the Tamala South System which is described as rises and low hills with relict dunes and some limestone outcrop on coastal limestone north of Jurien Bay. Yellow deep sands common, with yellow/brown shallow sands and calcareous shallow and deep sands. Banksia woodlands and heathlands (DPIRD, 2023).
Waterbodies	The desktop assessment and aerial imagery indicated that no watercourses transect the area proposed to be cleared (GIS Database).
Hydrogeography	The application area is located within the Arrowsmith Groundwater Area which is legislated by the <i>RIWI Act 1914</i> . The mapped groundwater salinity is 1,000-7,000 milligrams per litre total dissolved solids which is described as brackish to saline (GIS Database).
Flora	There are no Priority or Threatened flora species records within the application area (GIS Database). There are records of 10 conservation significant flora species within the local area (20 kilometre radius) that are possible to occur within the application area (GIS Database).
Ecological communities	The application area does not intersect any known or mapped Priority or Threatened Ecological Communities (GIS Database). The closest record is the Priority 1 'coastal sands dominated by <i>Acacia rostellifera</i> , <i>Eucalyptus oraria</i> and <i>Eucalyptus obtusiflora</i> ' Ecological Community, located approximately 1.6 kilometres southwest of the application area (GIS Database).
Fauna	There are no records of Priority or Threatened fauna specie s within the application area (GIS Database). There are records of seven conservation significant fauna species within the local area (20 kilometre radius) that are possible to occur in the application area (GIS Database).

There are various records of these environmental values in the local area (within 20 kilometres of the application area) (GIS Database). If any of these environmental values were to be present within the application area, it is unlikely that the proposed clearing would have any significant impacts on them due to the small scale of the proposed clearing. Given the level of disturbance around the application area, it is unlikely that the application area would be suitable habitat for any of the conservation significant flora and fauna species recorded in the local area.			
Weeds have the potential to significantly change the dynamics of a natural ecosystem and lower the biodiversity of an area. Potential impacts to the biodiversity as a result of the proposed clearing may be minimised by the implementation of a weed management condition.

This vegetation association has not been extensively cleared as over 45 per cent of the pre-European extent of this vegetation association remains uncleared at both the state and bioregional level (Government of Western Australia, 2019).

Given the distance to the nearest conservation area, the proposed clearing is not likely to have an impact on the environmental values of nearby conservation areas (GIS Database).

Given no water courses or wetlands are recorded within the application area (GIS Database), the proposed clearing is unlikely to impact vegetation growing in, or in association with, an environment associated with a watercourse or wetland.

Assessment:		
The mapped soils are susceptible to wind erosion (DPIRD, 2023). However, noting the size of the application area, the proposed clearing is not likely to cause appreciable land degradation.

Given no water courses, wetlands, or Public Drinking Water Source Areas are recorded within the application area (GIS Database), the proposed clearing is unlikely to cause deterioration in the quality of surface or underground water.

Given no water courses or wetlands are recorded within the application area (GIS Database), the proposed clearing is unlikely to cause, or exacerbate, the incidence or intensity of flooding.		

# Appendix C. Vegetation condition rating scale

Vegetation condition is a rating given to a defined area of vegetation to categorise and rank disturbance related to human activities. The rating refers to the degree of change in the vegetation structure, density and species present in relation to undisturbed vegetation of the same type. The degree of disturbance impacts upon the vegetation's ability to regenerate. Disturbance at a site can be a cumulative effect from a number of interacting disturbance types.

Considering its location, the scale below was used to measure the condition of the vegetation proposed to be cleared. This scale has been extracted from Keighery, B.J. (1994) *Bushland Plant Survey: A Guide to Plant Community Survey for the Community*. Wildflower Society of WA (Inc). Nedlands, Western Australia.

## Measuring vegetation condition for the South West and Interzone Botanical Province (Keighery, 1994)

<u> </u>			
Condition	Description		
Pristine	Pristine or nearly so, no obvious signs of disturbance.		
Excellent	Vegetation structure intact, with disturbance affecting individual species; weeds are non-aggressive species.		

Condition	Description
Very good	Vegetation structure altered, with obvious signs of disturbance. For example, disturbance to vegetation structure caused by repeated fires, the presence of some more aggressive weeds, dieback, logging and/or grazing.
Good	Vegetation structure significantly altered by very obvious signs of multiple disturbances. Retains basic vegetation structure or ability to regenerate it. For example, disturbance to vegetation structure caused by very frequent fires, the presence of some very aggressive weeds at high density, partial clearing, dieback and/or grazing.
Degraded	Basic vegetation structure severely impacted by disturbance. Scope for regeneration but not to a state approaching good condition without intensive management. For example, disturbance to vegetation structure caused by very frequent fires, the presence of very aggressive weeds, partial clearing, dieback and/or grazing.
Completely degraded	The structure of the vegetation is no longer intact and the area is completely or almost completely without native species. These areas are often described as 'parkland cleared' with the flora comprising weed or crop species with isolated native trees or shrubs.

#### T Threatened species:

Listed by order of the Minister as Threatened in the category of critically endangered, endangered or vulnerable under section 19(1), or is a rediscovered species to be regarded as threatened species under section 26(2) of the *Biodiversity Conservation Act 2016* (BC Act).

**Threatened fauna** is that subset of 'Specially Protected Fauna' listed under schedules 1 to 3 of the Wildlife Conservation (Specially Protected Fauna) Notice 2018 for Threatened Fauna.

Published under schedule 2 of the *Wildlife Conservation* (Specially Protected Fauna) Notice 2018 for endangered fauna or the *Wildlife Conservation* (Rare Flora) Notice 2018 for endangered flora.

Threatened species considered to be "facing a high risk of extinction in the wild in the medium-term future, as determined in accordance with criteria set out in the ministerial guidelines".

Species that "is known only to survive in cultivation, in captivity or as a naturalised population well outside its past range; and it has not been recorded in its known habitat or expected habitat, at appropriate seasons, anywhere in its past range, despite surveys over a time frame appropriate to its life cycle and form", and listing is otherwise in accordance with the ministerial guidelines (section 25 of the BC Act).

Currently there are no threatened fauna or threatened flora species listed as extinct in the wild. If listing of a species as extinct in the wild occurs, then a schedule will be added to the applicable notice.

#### **Specially protected species:**

Listed by order of the Minister as specially protected under section 13(1) of the BC Act. Meeting one or more of the following categories: species of special conservation interest; migratory species; cetaceans; species subject to international agreement; or species otherwise in need of special protection.

Species that are listed as threatened species (critically endangered, endangered or vulnerable) or extinct species under the BC Act cannot also be listed as Specially Protected species.

## MI Migratory species

Fauna that periodically or occasionally visit Australia or an external Territory or the exclusive economic zone; or the species is subject of an international agreement that relates to the protection of migratory species and that binds the Commonwealth; and listing is otherwise in accordance with the ministerial guidelines (section 15 of the BC Act).

Includes birds that are subject to an agreement between the government of Australia and the governments of Japan (JAMBA), China (CAMBA) and The Republic of Korea (ROKAMBA), and fauna subject to the *Convention on the Conservation of Migratory Species of Wild Animals* (Bonn Convention), an environmental treaty under the United Nations Environment Program. Migratory species listed under the BC Act are a subset of the migratory animals, that are known to visit Western Australia, protected under the international agreements or treaties, excluding species that are listed as Threatened species.

Published as migratory birds protected under an international agreement under schedule 5 of the Wildlife Conservation (Specially Protected Fauna) Notice 2018.

## CD Species of special conservation interest (conservation dependent fauna)

Fauna of special conservation need being species dependent on ongoing conservation intervention to prevent it becoming eligible for listing as threatened, and listing is otherwise in accordance with the ministerial guidelines (section 14 of the BC Act).

Published as conservation dependent fauna under schedule 6 of the Wildlife Conservation (Specially Protected Fauna) Notice 2018.

#### OS Other specially protected species

Fauna otherwise in need of special protection to ensure their conservation, and listing is otherwise in accordance with the ministerial guidelines (section 18 of the BC Act).

Published as other specially protected fauna under schedule 7 of the Wildlife Conservation (Specially Protected Fauna) Notice 2018.

# P Priority species:

Possibly threatened species that do not meet survey criteria, or are otherwise data deficient, are added to the Priority Fauna or Priority Flora Lists under Priorities 1, 2 or 3. These three categories are ranked in order of priority for survey and evaluation of conservation status so that consideration can be given to their declaration as threatened fauna or flora.

Species that are adequately known, are rare but not threatened, or meet criteria for near threatened, or that have been recently removed from the threatened species or other specially protected fauna lists for other than taxonomic reasons, are placed in Priority 4. These species require regular monitoring.

Assessment of Priority codes is based on the Western Australian distribution of the species, unless the distribution in WA is part of a contiguous population extending into adjacent States, as defined by the known spread of locations.

# P1 Priority One - Poorly-known species

Species that are known from one or a few locations (generally five or less) which are potentially at risk. All occurrences are either: very small; or on lands not managed for conservation, e.g. agricultural or pastoral lands, urban areas, road and rail reserves, gravel reserves and active mineral leases; or

otherwise under threat of habitat destruction or degradation. Species may be included if they are comparatively well known from one or more locations but do not meet adequacy of survey requirements and appear to be under immediate threat from known threatening processes. Such species are in urgent need of further survey.

## P2 Priority Two - Poorly-known species

Species that are known from one or a few locations (generally five or less), some of which are on lands managed primarily for nature conservation, e.g. national parks, conservation parks, nature reserves and other lands with secure tenure being managed for conservation. Species may be included if they are comparatively well known from one or more locations but do not meet adequacy of survey requirements and appear to be under threat from known threatening processes. Such species are in urgent need of further survey.

# P3 Priority Three - Poorly-known species

Species that are known from several locations, and the species does not appear to be under imminent threat, or from few but widespread locations with either large population size or significant remaining areas of apparently suitable habitat, much of it not under imminent threat. Species may be included if they are comparatively well known from several locations but do not meet adequacy of survey requirements and known threatening processes exist that could affect them. Such species are in need of further survey.

## P4 Priority Four - Rare, Near Threatened and other species in need of monitoring

- (a) Rare. Species that are considered to have been adequately surveyed, or for which sufficient knowledge is available, and that are considered not currently threatened or in need of special protection but could be if present circumstances change. These species are usually represented on conservation lands.
- (b) Near Threatened. Species that are considered to have been adequately surveyed and that are close to qualifying for vulnerable but are not listed as Conservation Dependent.
- (c) Species that have been removed from the list of threatened species during the past five years for reasons other than taxonomy.

# Principles for clearing native vegetation:

- (a) Native vegetation should not be cleared if it comprises a high level of biological diversity.
- **(b)** Native vegetation should not be cleared if it comprises the whole or a part of, or is necessary for the maintenance of, a significant habitat for fauna.
- (c) Native vegetation should not be cleared if it includes, or is necessary for the continued existence of, threatened flora.
- (d) Native vegetation should not be cleared if it comprises the whole or a part of, or is necessary for the maintenance of a threatened ecological community.
- (e) Native vegetation should not be cleared if it is significant as a remnant of native vegetation in an area that has been extensively cleared.
- (f) Native vegetation should not be cleared if it is growing in, or in association with, an environment associated with a watercourse or wetland.
- (g) Native vegetation should not be cleared if the clearing of the vegetation is likely to cause appreciable land degradation.
- (h) Native vegetation should not be cleared if the clearing of the vegetation is likely to have an impact on the environmental values of any adjacent or nearby conservation area.
- (i) Native vegetation should not be cleared if the clearing of the vegetation is likely to cause deterioration in the quality of surface or underground water.
- (j) Native vegetation should not be cleared if the clearing of the vegetation is likely to cause, or exacerbate, the incidence or intensity of flooding.
