

#### **CLEARING PERMIT**

Granted under section 51E of the Environmental Protection Act 1986

**Purpose Permit number:** CPS 10664/1

**Permit Holder:** APA Pilbara Holdings Pty Ltd

**Duration of Permit:** From 29 September 2024 to 29 September 2029

The permit holder is authorised to clear *native vegetation* subject to the following conditions of this permit.

#### PART I – CLEARING AUTHORISED

## 1. Clearing authorised (purpose)

The permit holder is authorised to clear *native vegetation* for the purpose of expanding the existing Chichester Power Project to increase operational capacity.

## 2. Land on which clearing is to be done

Miscellaneous Licence 46/138

## 3. Clearing authorised




Figure 1: Map of the boundary of the area within which clearing may occur

The permit holder must not clear more than 105.2 hectares of *native vegetation* within the area cross-hatched yellow in Figure 1 of Schedule 1.

#### 4. Period during which clearing is authorized

The permit holder must not clear any *native vegetation* after 29 September 2029.

## **PART II – MANAGEMENT CONDITIONS**

## 5. Avoid, minimise, and reduce impacts and extent of clearing

In determining the *native vegetation* authorised to be cleared under this permit, the permit holder must apply the following principles, set out in descending order of preference:

- (a) avoid the clearing of *native vegetation*;
- (b) minimise the amount of *native vegetation* to be cleared; and
- (c) reduce the impact of clearing on any environmental value.

## 6. Weed management

When undertaking any clearing authorised under this permit, the permit holder must take the following measures to minimise the risk of introduction and spread of *weeds*:

- (a) clean earth-moving machinery of soil and vegetation prior to entering and leaving the area to be cleared;
- (b) ensure that no known *weed*-affected soil, *mulch*, *fill*, or other material is brought into the area to be cleared; and
- (c) restrict the movement of machines and other vehicles to the limits of the areas to be cleared.

## 7. Directional clearing

The permit holder must conduct clearing activities in a slow, progressive manner towards adjacent *native vegetation* to allow fauna to move into adjacent *native vegetation* ahead of the clearing activity.

#### 8. Vegetation management

The permit holder must:

- (a) where practicable the permit holder shall avoid *clearing riparian vegetation*; and
- (b) where a *watercourse* or *drainage line* is to be impacted by clearing, the permit holder shall ensure that the existing surface flow is maintained, or reinstated downstream into existing natural *drainage lines*.

#### PART III - RECORD KEEPING AND REPORTING

## 9. Records that must be kept

The permit holder must maintain records relating to the listed relevant matters in accordance with the specifications detailed in Table 1.

		(f)	actions taken to minimise the risk of the introduction and spread of <i>weeds</i> in accordance with condition 6, and

# 10. Reporting

The permit holder must provide to the *CEO* the records required under condition 8 of this permit when requested by the *CEO*.

# **DEFINITIONS**

In this permit, the terms in Table 2 have the meanings defined.

clearing	has the meaning given under section 3(1) of the EP Act.

department	means the department established under section 35 of the <i>Public Sector Management Act 1994</i> (WA) and designated as responsible for the administration of the EP Act, which includes Part V Division 3.			
drainage line/s	means a natural depression that carries surface water runoff.			
EP Act	Environmental Protection Act 1986 (WA)			
fill	means material used to increase the ground level, or to fill a depression.			
mulch	means the use of organic matter, wood chips or rocks to slow the movement of water across the soil surface and to reduce evaporation.

The boundary of the area authorised to be cleared is shown in the map below (Figure 1).
