## Application to amend a clearing permit

Environmental Protection Act 1986, section 51KA

The clearing of native vegetation is prohibited in Western Australia unless a clearing permit has been granted for the clearing or where a permit is not required (either due to a referral determination that one is not needed or because an exemption applies). The total area cleared under the current permit since the commencement date (19 July 2025) is 11.49Ha. <b>This amendment seeks to increase the total area to be cleared from 100ha to 175ha to facilitate mining activities approved under mining proposals REG ID 500367 and REG ID 129299.</b></p> <p>On 8/09/2025 Mining Proposal REG ID 500367 for a cutback of the Lord Byron Pit was approved increasing the footprint of disturbance. The total area of disturbance (current approved area + proposed area) for the project will be 236.0 ha. To accommodate the WRL, pit cutback and support infrastructure a total of 138Ha of clearing is required.</p> <p>Additional disturbance of the Fish Mine was also approved under Mining Proposal REG ID 129299 for the Fish Underground Mine including expansion of the existing WRL, camp and site infrastructure. Total new disturbance approved was 24.47Ha.</p>
