## Application to amend a clearing permit

*Environmental Protection Act 1986, section 51KA*

### FORM C4

The clearing of native vegetation is prohibited in Western Australia unless a clearing permit has been granted for the clearing or where a permit is not required (either due to a referral determination that one is not needed or because an exemption applies). A person who causes or allows unauthorised clearing commits an offence.

As discussed with the department, amending the local province definition was considered acceptable (email correspondence attached).</p> <p>We first engaged with our tree supplier in May about the procurement of trees for this winter planting, and trees were purchased in the last financial year. Due to the timing of the permit being granted and the requirement about planting time, a delay in sourcing 'local provenance' trees would have delayed planting for 12 months.
