**Application to Clear Native Vegetation – Lot 501 Coalfields Road, Roelands, Shire of Harvey**

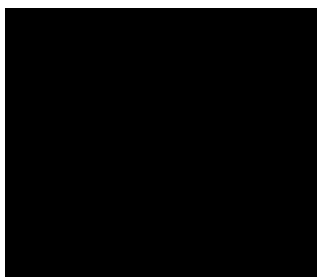
