



CLEARING PERMIT

Granted under section 51E of the Environmental Protection Act 1986

Purpose permit number:	11183/1
Duration of permit:	29 March 2026 to 28 March 2031
Permit holder:	White Star Minerals Pty Ltd

The permit holder is authorised to clear native vegetation subject to the following conditions of this permit.

PART I – CLEARING AUTHORISED

1. Land on which clearing is to be done

Mining Lease 51/888
Miscellaneous Licence 51/112

2. Clearing authorised (purpose)

The permit holder is authorised to clear native vegetation for the purpose of mineral production and associated activities.

3. Area of clearing

The permit holder must not clear more than 45 hectares of native vegetation within the area cross-hatched yellow in Figure 1 of Schedule 1.

4. Directional clearing

The permit holder shall:

- conduct all clearing authorised under this permit in one direction towards adjacent vegetation;
- allow a reasonable time for fauna present within the area being cleared to move into that adjacent native vegetation ahead of the clearing activity; and
- engage a fauna spotter to traverse the project area ahead of clearing machinery at the time of clearing and alert machinery operators to avoid fauna.

PART II – MANAGEMENT CONDITIONS

5. Avoid, minimise and reduce the impacts and extent of clearing

In determining the amount of native vegetation to be cleared under this permit, the permit holder must apply the following principles, set out in descending order of preference:

- avoid the clearing of native vegetation;
- minimise the amount of native vegetation to be cleared; and
- reduce the impact of clearing on any environmental value.

6. Flora management

Where the *priority flora* species *Acacia speckii*, *Dodonaea amplisemina* and *Ptilotus luteolus* have been

identified and their written locations, provided to the *CEO*, within the report ‘Supporting documentation received in relation to White Star Minerals Pty Ltd clearing permit application CPS 11183/1 – prepared for White Star Minerals by Preston Consulting Pty Ltd, July 2025’, as retained on the Department of Mines, Petroleum and Exploration file DMS09734/2025, Object ID qA2661102, the permit holder shall ensure that:

- (a) clearing of identified *priority species* is kept to the minimum amount necessary to develop the proposed *site envelope* as specified in the aforementioned Supporting Documentation:
 - (i) no more than 73 individual plants of identified *Acacia speckii* are cleared;
 - (ii) no more than 288 individual plants of identified *Dodonaea amplusemina* are cleared; and
 - (iii) no more than 381 individual plants of identified *Ptilotus luteolus* are cleared.

7. Weed control

When undertaking any clearing or other activity authorised under this permit, the permit holder must take the following steps to minimise the risk of the introduction and spread of *weeds*:

- (a) clean earth-moving machinery of soil and vegetation prior to entering and leaving the area to be cleared;
- (b) ensure that no known *weed*-affected soil, *mulch*, *fill* or other material is brought into the area to be cleared; and
- (c) restrict the movement of machines and other vehicles to the limits of the areas to be cleared.

8. Vegetation management

- (a) where practicable the permit holder shall avoid clearing *riparian vegetation*; and
- (b) where a *watercourse* or *drainage line* is to be impacted by clearing, the permit holder shall ensure that the existing surface flow is maintained or reinstated downstream into existing natural *drainage lines*.

9. Fauna management (southern whiteface)

Where clearing authorised under this Permit is to occur between 1 July and 31 October, the Permit Holder shall:

- (a) within two weeks prior to undertaking any clearing, engage a *fauna specialist* to conduct an inspection of the area to be cleared to identify *active (in use) Southern whiteface (Aphelocephala leucopsis) nests*; and
- (b) where an *active (in use) Southern whiteface (Aphelocephala leucopsis) nest* is identified under Condition 10(a) of this Permit, the Permit Holder shall ensure that no clearing occurs within 50 metres of the nest, during the months of July through to October, unless first approved by the *CEO*.

PART III – RECORD KEEPING AND REPORTING

10. Records to be kept

The permit holder must maintain records relating to the listed relevant matters in accordance with the specifications detailed in Table 1.

2.	In relation to flora management pursuant to Condition 6	(a) The name and location of each <i>priority flora</i> species, recorded using a Global Positioning System (GPS) unit set to Geocentric Datum Australia 2020 (GDA20), expressing the geographical coordinates in Eastings and Northings; (b) Actions taken to demarcate each <i>priority flora</i> species recorded and their relevant buffers; and (c) Actions taken to avoid the clearing of <i>priority flora</i> species.
3.	In relation to fauna management pursuant to Condition 9	(d) the location of each active (in use) Southern whiteface (<i>Aphelocephala leucopsis</i>) nest, recorded using a Global Positioning System (GPS) unit set to Geocentric Datum of Australia 2020 (GDA2020), expressing the geographical coordinates in Eastings and Northings or decimal degrees; (e) actions taken to demarcate each active (in use) Southern whiteface (<i>Aphelocephala leucopsis</i>) nest recorded and their relevant buffers; and (f) actions taken to avoid the clearing of active (in use) Southern whiteface (<i>Aphelocephala leucopsis</i>) nests.

11. Reporting

- (a) The permit holder must provide a written report to the *CEO* by 31 July each year for the life of this permit, demonstrating adherence to all conditions of this permit, and setting out the records required under condition 10 of this permit in relation to clearing carried out between 1 July and 30 June of the previous financial year.
- (b) If no clearing authorised under this permit was undertaken between 1 July and 30 June of the previous financial year, a written report confirming that no clearing under this permit has been carried out, must be provided to the *CEO* by 31 July of each year.
- (c) Prior to 28 March 2031, the permit holder must provide to the *CEO* a written report of records required under condition 10 of this permit where these records have not already been provided under condition 11(a) or 11(b) of this permit.

DEFINITIONS

In this permit, the terms in Table 2 have the meanings defined.

Table 2: Definitions

Term	Definition
active (in use) Southern whiteface nest	means a nest with evidence of current Southern whiteface (<i>Aphelocephala leucopsis</i>) activity, such as fresh nesting material (grass, bark and roots), a breeding pair, eggs, or hatchlings.
CEO	the Chief Executive Officer of the Department responsible for administering the clearing provisions contained within the <i>Environmental Protection Act 1986</i> or an Officer with delegated authority under Section 20 of the <i>Environmental Protection Act 1986</i> .
clearing	has the meaning given under section 3(1) of the EP Act.
condition(s)	a condition to which this clearing permit is subject under section 51H of the EP Act.
department	means the department established under section 35 of the <i>Public Sector Management Act 1994</i> (WA) and designated as responsible for the administration of the EP Act, which includes Part V Division 3.

Term	Definition
drainage line(s)	means a natural depression that carries surface water runoff.
EP Act	<i>Environmental Protection Act 1986 (WA)</i>
fauna specialist	means a person who holds a tertiary qualification specialising in environmental science or equivalent, and has a minimum of 2 years work experience in fauna identification and surveys of fauna native to the region being inspected or surveyed, or who is approved by the <i>CEO</i> as a suitable fauna specialist for the bioregion, and who holds a valid fauna licence issued under the <i>Biodiversity Conservation Act 2016</i> .
fill	means material used to increase the ground level, or to fill a depression.
mulch	means the use of organic matter, wood chips or rocks to slow the movement of water across the soil surface and to reduce evaporation.
native vegetation	has the meaning given under section 3(1) and section 51A of the EP Act.
priority flora	means those plant taxa described as priority flora classes 1, 2, 3, or 4 in the Department of Biodiversity, Conservation and Attractions' Threatened and Priority Flora List for Western Australia (as amended).
riparian vegetation	has the meaning given to it in Regulation 3 of the Environmental Protection (Clearing of Native Vegetation) Regulations 2004.
site envelope	means the area within the application area where proposed site activities will be developed.
watercourse	has the meaning given to it in section 3 of the <i>Rights in Water and Irrigation Act 1914</i> .
weed(s)	means any plant – (a) that is a declared pest under section 22 of the <i>Biosecurity and Agriculture Management Act 2007</i> ; or (b) published in a Department of Biodiversity, Conservation and Attractions species-led ecological impact and invasiveness ranking summary, regardless of ranking; or (c) not indigenous to the area concerned.




Figure 1: Map of the boundary of the area within which clearing may occur.

The boundary of the area authorised to be cleared is shown in the map below (Figure 1).
