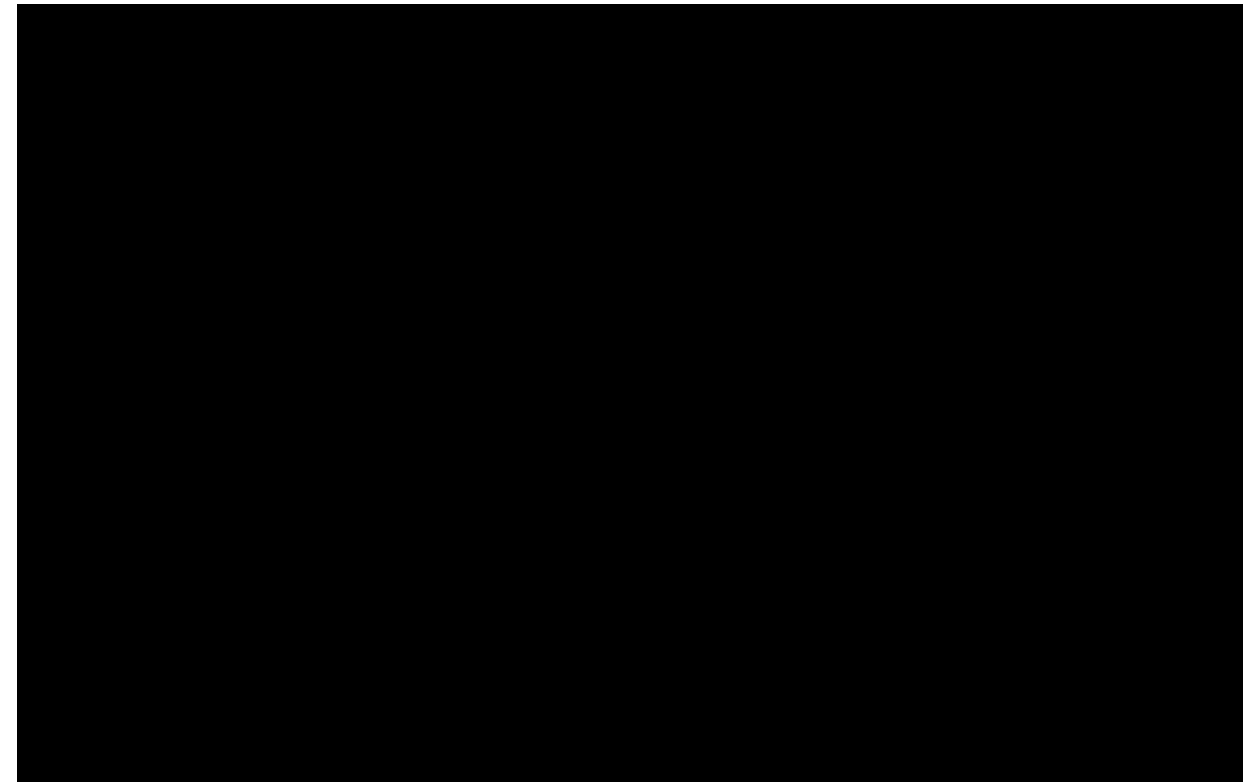
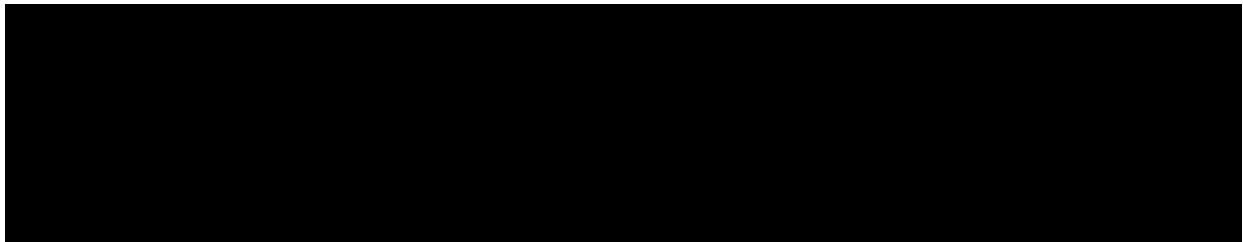

Final land use after clearing	There are two purposes of the proposed activities. First proposed activity is to reduce the fuel load and clear selected vegetation on the verges of the constructed portion of Cromwell Rd. This is to support safer evacuation as this is a dead end road. The current constructed part of the road is between 3-4m in width and does not support two way traffic. Additionally powerlines on the northern side of the road reserve means the vegetation along this corridor is continually compromised by vegetation removal/modification to maintain powerline clearances. The Shire also has adopted the BAAS (Bushfire Area Access Strategy) which classifies all entrapment points in the Shire and any potential solutions. These works support the BAAS. Second purpose is to widen the existing firebreak that traverses over R38980 to upgrade it to all weather trafficable surface to act as an Emergency Access Way (EAW) for the public to use in an emergency situation. This reserve has previously been a road reserve as there is water mains and powerlines traversing this parcel.

Avoidance details	Shire of Mundaring Environmental Officers have performed several site visits and have produced a report (attached) noting habitat tree's for retention and avoidance. As these are existing tracks they have been the subject of much disturbance in the past from utility installation and maintenance.
Mitigation details	Habitat tree's have been identified and will be protected on-site during works. There are isolated stands of invasive wattles and non-native tee tree which will be removed during the works. Bi-annual follow up spraying will also occur to manage any regrowth.
