- Any other person who disagrees with a requirement contained in this vegetation conservation notice
 may within 21 days of the making of that requirement lodge with the Minister for the Environment
 an appeal in writing setting out the grounds of that appeal.

PENDING THE DETERMINATION OF AN APPEAL REFERRED TO ABOVE, THE REVELANT REQUIREMENTS CONTAINED IN THIS VEGETATION CONSERVATION NOTICE CONTINUE TO HAVE EFFECT.
