PURPOSE FOR WHICH THE CLEARING MAY BE DONE

Clearing for the purposes of Phosphate Mining.

CONDITIONS

1. The Permit Holder must not clear more than 76.6 hectares of native vegetation within the areas hatched yellow on attached Plan 2132/2a, Plan 2132/2b, Plan 2132/2c, Plan 2132/2d and Plan 2132/2e.

2. Avoid, minimise etc clearing

In determining the amount of native vegetation to be cleared for the purpose of road upgrades, the Permit Holder must have regard to the following principles, set out in order of preference:

- (a) avoid the clearing of native vegetation;
- (b) minimise the amount of native vegetation to be cleared; and
- (c) reduce the impact of clearing on any environmental value.

3. Weed control

(a) When undertaking any clearing, or other activity pursuant to this Permit the Permit Holder must take the following steps to minimise the risk of the introduction and spread of *weeds*

- (i) clean earth-moving machinery of soil and vegetation prior to entering and leaving the area to be cleared;
- (ii) ensure that no *weed-affected road building materials, mulch, fill* or other material is brought into the area to be cleared; and
- (iii) restrict the movement of machines and other vehicles to the limits of the areas to be cleared.

(b) At least once in each 3 month period for the *term* of this Permit, the Permit Holder must remove or kill any *weeds* growing within areas cleared under this Permit.

4. Rehabilitation

Areas permitted to be cleared must be rehabilitated within 6 months of the completion of phosphate mining by:

- (a) Creating a slope of 15 degrees or less around the edges of the pit.
- (b) Fell limestone pinnacles
- (c) Level pit floor by crushing all rocks and material within the area cross hatched yellow on attached Plan 2132/2a, Plan 2132/2b, Plan 2132/2c, Plan 2132/2d and Plan 2132/2e to a minimum of 5cm in diameter.

5. Records must be kept

The Permit Holder must maintain the following records for activities done pursuant to this Permit, as relevant:

- (a) In relation to the clearing of native vegetation undertaken pursuant to this permit:
 - (i) the species composition, structure and density of the cleared area;
 - (ii) the location where the clearing occurred, recorded using Geocentric Datum Australia 1994;
 - (iii) the date that the area was cleared; and
 - (iv) the size of the area cleared (in hectares).

- (b) In relation to the rehabilitation of areas pursuant to condition 4:
 - (i) the commencement date of rehabilitation;
 - (ii) the location of any area rehabilitation recorded using Geocentric Datum Australia 1994;
 - (iii) a description of the rehabilitation activities undertaken; and
 - (iv) the size of the area rehabilitation (in hectares).

6 Reporting

(a) The Permit Holder must provide to the CEO, on or before 30 June of each year, a written report of records required under condition 5 of this Permit and activities done by the Permit Holder under this Permit between 1 January and 31 December of the preceding year.

(b) Prior to 11 August 2022, the Permit Holder must provide to the CEO a written report of records required under condition 5 of this Permit where these records have not already been provided under condition 6a) of this Permit.

DEFINITIONS


The following meanings are given to terms used in this Permit:

fill means material used to increase the ground level, or fill a hollow;

mulch means the use of organic matter, wood chips or rocks to slow the movement of water across the soil surface and to reduce evaporation;

term means the duration of this Permit, including as amended or renewed;

weed means a species listed in Appendix 3 of the "Environmental Weed Strategy" published by the Department of Conservation and Land Management (1999), and plants declared under section 37 of the Agricultural and Related Resources Protection Act 1976.
