

# **CLEARING PERMIT**

Granted under section 51E of the Environmental Protection Act 1986

**Purpose Permit number:** 2160/4

**Duration of Permit:** From 21 June 2008 to 30 November 2033

**Permit Holder:** BHP Iron Ore Pty Ltd

The Permit Holder is authorised to clear native vegetation subject to the following conditions of this Permit.

## PART I - CLEARING AUTHORISED

### 1. Land on which clearing is to be done

Iron Ore (Mount Newman) Agreement Act 1964, Mineral Lease 244SA (AML 70/244).

#### 2. Clearing authorised (purpose)

Clearing for the purposes of mineral exploration, hydrological investigations, geotechnical investigations, weather masts, supporting infrastructure and associated activities.

# 3. Area of Clearing




Figure 1: Map of the boundary of the area within which clearing may occur

The Permit Holder must not clear more than 105 hectares of native vegetation within the area cross-hatched yellow in Figure 1 of Schedule 1.

## 4. Period in which clearing is Authorised

The Permit Holder must not clear any native vegetation after 30 November 2027.

## **PART II - MANAGEMENT CONDITIONS**

### 5. Avoid, minimise and reduce the impacts and extent of clearing

In determining the amount of native vegetation to be cleared under this Permit, the Permit Holder must apply the following principles, set out in descending order of preference:

- (a) avoid the clearing of native vegetation;
- (b) minimise the amount of native vegetation to be cleared; and
- (c) reduce the impact of clearing on any environmental value.

### 6. Weed control

When undertaking any clearing or other activity authorised under this Permit, the Permit Holder must take the following steps to minimise the risk of the introduction and spread of *weeds*:

- (a) clean earth-moving machinery of soil and vegetation prior to entering and leaving the area to be cleared;
- (b) ensure that no known weed-affected soil, mulch, fill or other material is brought into the area to be cleared;
- (c) restrict the movement of machines and other vehicles to the limits of the areas to be cleared;

#### 7. Vegetation Management

- (a) where practicable the Permit Holder shall avoid clearing riparian vegetation; and
- (b) where a *watercourse* or *drainage line* is to be impacted by clearing, the Permit Holder shall ensure that the existing surface flow is maintained, or reinstated downstream into existing natural drainage lines.

#### 8. Flora Management

- (a) Where *priority flora* have been identified and their written locations provided to the *CEO*, within report 'Application to Amend NVCP CPS 2160/3 Ninga Native Vegetation Clearing Permit Amendment Application Supporting Document, August 2023' as retained on Department of Mines, Industry Regulation and Safety File No. A2004/201601 as Object ID A69051574, the Permit Holder shall ensure that:
  - (i) no clearing of identified *priority flora* occurs, unless first approved by the CEO.
  - (ii) no clearing occurs within 10 metres of identified *priority flora*, unless first approved by the CEO.

## 9. Retain vegetative material and topsoil, revegetation and rehabilitation

The Permit Holder shall:

- (a) retain the vegetative material and topsoil removed by clearing authorised under this Permit and stockpile the vegetative material and topsoil in an area that has already been cleared;
- (b) within 12 months following completion of clearing authorised under this Permit, *revegetate* and *rehabilitate* the areas that are no longer required for the purpose for which they were cleared under this Permit by:
  - (i) ripping the ground on the contour to remove soil compaction;
  - (ii) laying the vegetative material and topsoil retained under Condition 9(a) on the cleared area;
- (c) within 4 years of undertaking *revegetation* and *rehabilitation* in accordance with Condition 9(b) of this Permit:
  - (i) engage an *environmental specialist* to determine the species composition, structure and density of the area *revegetated* and *rehabilitated*; and
  - (ii) where, in the opinion of an *environmental specialist*, the composition structure and density determined under Condition 9(c)(i) of this Permit will not result in a similar species composition, structure and density to that of pre-clearing vegetation types in that area, revegetate the area by deliberately planting and/or direct seeding native vegetation that will result in a similar species composition, structure and density of native vegetation to pre-clearing vegetation types in that area and ensuring only local provenance seeds and propagating material are used.

### PART III - RECORD KEEPING AND REPORTING

# 10. Records to be kept

The Permit Holder must maintain records relating to the listed relevant matters in accordance with the specifications detailed in Table 1.

### 11. Reporting

- (a) The Permit Holder shall provide a report to the *CEO* by 1 October each year for the life of this Permit, demonstrating adherence to all conditions of this Permit, and setting out the records required under Condition 10 of this Permit in relation to clearing carried out between 1 July and 30 June of the previous financial year.
- (b) If no clearing authorised under this Permit was undertaken between 1 July and 30 June of the previous financial year, a written report confirming that no clearing under this permit has been carried out, must be provided to the *CEO* by 1 October of each year.
- (c) Prior to 30 November 2033, the Permit Holder must provide to the *CEO* a written report of records required under Condition 10 of this Permit where these records have not already been provided under Condition 11(a) or 11(b) of this Permit.

### **DEFINITIONS**

In this permit, the terms in Table 2 have the meanings defined.

rehabilitate / rehabilitated / rehabilitation	means actively managing an area containing native vegetation in order to improve the ecological function of that area.

The boundary of the area authorised to be cleared is shown in the map below (Figure 1).
