The permit holder is authorised to clear native vegetation for the above stated purposes, subject to the conditions of this Permit.

PART I - CLEARING AUTHORISED

1. Land on which clearing is to be done

Lot 1 on Plan 41094 Lot 10 on Plan 93163 Lot 9 on Plan 91722

2. Area of Clearing

Clearing of up to 80 hectares of native vegetation within the areas shaded yellow on attached Plan 2165/1a, Plan 2165/1b and Plan 2165/1c.

3. Application

This Permit allows the permit holder to authorise persons, including employees, contractors and agents of the permit holder, to clear native vegetation for the purposes of this Permit subject to compliance with the conditions of this Permit and approval from the Permit Holder.

4. Type of Clearing Authorised

This Permit authorises the permit holder to clear native vegetation for activities to the extent that the permit holder has the power to clear native vegetation for those activities under the *Local Government Act 1995* or any other written law.

5. Compliance with Assessment Sequence and Management Procedures

Prior to clearing any native vegetation under conditions 1 and 2 of this Permit, the permit holder must comply with the Assessment Sequence and the Management Procedures set out in Part II of this Permit.

PART II - ASSESSMENT SEQUENCE AND MANAGEMENT PROCEDURES

6. Avoid, minimise etc clearing

In determining the amount of native vegetation to be cleared for the purposes of gravel extraction the Permit Holder must have regard to the following principles, set out in order of preference:

- (a) avoid the clearing of native vegetation;
- (b) minimise the amount of native vegetation to be cleared; and
- (c) reduce the impact of clearing on any environmental value.

7. Revegetation

- (a) The Permit Holder shall retain the vegetative material and topsoil removed by clearing in accordance with this Permit.
- (b) Within one month of the area no longer being required for the purpose of gravel extraction the permit holder must *revegetate* the area by laying vegetative material and topsoil retained in accordance with condition 7(a) on the area.
- (c) Prior to undertaking works pursuant to condition 7(b) the permit holder shall rip pit floor and contour batters within the gravel extraction site.

PART III - RECORD KEEPING AND REPORTING

8. Records must be kept

The Permit Holder must maintain the following records for activities done pursuant to this Permit, as relevant:

- (a) In relation to the clearing of native vegetation undertaken pursuant to the purpose of clearing:
 - (i) The species composition, structure and density of the cleared area;
 - (ii) The location where the clearing occurred, recorded using Geocentric Datum Australia 1994;
 - (iii) The date that the area was cleared; and
 - (iv) The size of the area cleared (in hectares).
- (b) In relation to the revegetation of areas pursuant to condition 7:
 - (i) The location of any are revegetated recorded using Geocentric Datum Australia 1994;
 - (ii) A description of the revegetation activities undertaken; and
 - (iii) The size of the area revegetated (in hectares).

9. Reporting

The Permit Holder must provide to the CEO, on or before 30 June of each year, a written report of records required under condition 7 and activities done by the Permit Holder under this Permit between 1 January and 31 December of the preceding year.

DEFINITIONS

The following meanings are given to terms used in this Permit:

revegetate, revegetation means the re-establishment of a cover of native vegetation in an area such that the species composition, structure and density is similar to pre-clearing vegetation types in that area, and can involve regeneration, direct seeding and/or planting.
