Environmental Protection Act 1986, section 51KA

The clearing of native vegetation is prohibited in Western Australia unless a clearing permit has been granted for the clearing or where a permit is not required (either due to a referral determination that one is not needed or because an exemption applies). A person who causes or allows unauthorised clearing commits an offence.

Part 1: Assessment bilateral agreement

It is requested that Condition 2 be amended to allow for flexibility to undertake potential activities such as hydrogeological and geotechnical investigations. It is also requested that 'resource definition drilling' is added as an activity to better reflect the mineral exploration activity.</p> <p>Condition 4 – Extend the 'no clearing after' and expiry date CPS 2283/6 currently prohibits any clearing to occur after 31 December 2022. This amendment requests an extension of the clearing period from 31 December 2022 to 31 December 2027 and requests the expiry also be extended from 31 December 2027 to 31 December 2032.</p>
