LOT 30 ON PLAN 207410 (CAMBALLIN 6728)

AUTHORISED ACTIVITY

Clearing of up to 2425 hectares of native vegetation within the area cross-hatched yellow on attached Plan 2286/1.

CONDITIONS

- 1. The Permit Holder shall not clear *native vegetation* within 200 metres of the *riparian vegetation* of any *watercourse* within the area cross-hatched yellow on Plan 2286/1.
- 2. Within six months of clearing the Permit Holder must deliberately plant and/or seed native pasture species collected from within a 50km radius of the area cross-hatched yellow on attached Plan 2286/1.
- 3. The Permit Holder must maintain the following records for activities done pursuant to this Permit:
 - (a) In relation to the clearing of native vegetation authorised under this Permit:
 - the location where the clearing occurred, recorded using a Global Positioning System (GPS) unit set to Geocentric Datum Australia 1994 (GDA94), expressing the geographical coordinates in Eastings and Northings;
 - (ii) the date that the area was cleared; and
 - (iii) the size of the area cleared (in hectares).
 - (b) In relation to the planting and/or seeding of areas pursuant to condition 2 of this Permit:
 - the location of any areas planted and/or seeded, recorded using a Global Positioning System (GPS) unit set to Geocentric Datum Australia 1994 (GDA94), expressing the geographical coordinates in Eastings and Northings;
 - (ii) the size of the area planted and/or seeded (in hectares); and
 - (iii) the species and density of planting and/or seeding.

4. Reporting

(a) The Permit Holder must provide to the CEO, on or before 30 June of each year, a written report of records required under condition 3 of this Permit and activities done by the Permit Holder under this Permit between 1 January and 31 December of the preceding year.

(b) Prior to 20 September 2013, the Permit Holder must provide to the CEO a written report of records required under condition 3 of this Permit where these records have not already been provided under condition 4(a) of this Permit.

Definitions

The following meanings are given to terms used in this Permit:

native vegetation has the meaning given to it in section 3 and section 51A of the Environmental Protection Act 1986;

riparian vegetation has the meaning given to it in Regulation 3 of the Environmental Protection (Clearing of Native Vegetation) Regulations 2004;

watercourse has the same meaning as it has in the Rights in Water and Irrigation Act 1914;
