LAND ON WHICH CLEARING IS TO BE DONE

Iron Ore (Mt Goldsworthy) Agreement Act 1964, Mineral Lease 281SA

PURPOSE FOR WHICH THE CLEARING MAY BE DONE

1. Clearing for the purposes of Mineral Exploration.

CONDITIONS

1. The Permit Holder must not clear more than 305 hectares of native vegetation. All clearing must be within the area cross-hatched yellow on attached Plan 2295/1.

2. Weed Control

When undertaking any clearing, rehabilitation, or other activity pursuant to this Permit, the Permit Holder must take the following steps to minimise the risk of the introduction and spread of *weeds*:

- (i) clean earth-moving machinery of soil and vegetation prior to entering and leaving the area to be cleared;
- (ii) ensure that no weed-affected *road building materials, mulch, fill* or other material is brought into the area to be cleared; and
- (iii) restrict the movement of machines and other vehicles to the limits of the areas to be cleared.

3. Vegetation Management

- a) Prior to clearing, the area approved to be cleared shall be walked, inspected and surveyed by a qualified botanist who shall identify if any Declared Rare or Priority Flora species are present within the area to be cleared. If any Declared Rare or Priority Flora species are identified, the Permit Holder shall not clear within 30 metres of these species, without prior written approval from the Director, Environment Division, Department of Industry and Resources.
- b) Without prior written approval from the Director, Environment Division, Department of Industry and Resources, the Permit Holder shall not clear within 30 metres of the following Map Grid Australia 1994 coordinates and shown in blue on attached Plan 2295/1A:
 - (i) ZONE 50 - 690210 mE 7456233 mN
 - (ii) ZONE 50 - 690135 mE 7456490 mN
 - (iii) ZONE 50 - 690204 mE 7456672 mN
 - (iv) ZONE 50 - 689431 mE 7456903 mN
 - (v) ZONE 50 - 689417 mE 7455822 mN
 - (vi) ZONE 50 - 688680 mE 7456346 mN

- (vii) ZONE 50 - 688758 mE 7456399 mN
 - (viii) ZONE 50 - 688436 mE 7456644 mN
- c) The Permit Holder shall not clear any native vegetation within the area shaded red on attached Plan 2295/1, without prior written approval from the Director, Environment Division, Department of Industry and Resources. Where approval is given, the following conditions will apply:
- (i) clearing shall be restricted to scrub rolling;
 - (ii) clearing shall occur during dry conditions; and
 - (iii) management measures will be implemented to prevent fire.

4. Fauna Management

- a) The Permit Holder shall not clear within 10 metres of *drainage lines*.
- b) The Permit Holder shall not clear within 10 metres of *gorges* and *gullies*.

5. Rehabilitation

- a) The Permit Holder shall stockpile all topsoil and native vegetation cleared under this permit, for use in rehabilitation.
- b) For each instance of clearing, the Permit Holder shall, within 12 months of the date of clearing, rehabilitate all cleared areas by re-shaping the surface of each cleared area using the topsoil removed during the clearing, so that the shape of the surface of the rehabilitated area is consistent with the shape of the surrounding 5 metres of uncleared land.

6. Reporting

- a) The Permit Holder shall record the following for each instance of clearing:
 - (i) the location of where the clearing occurred, expressed as grid coordinates using the Geocentric Datum of Australia 1994 coordinate system;
 - (ii) the size of the area cleared in hectares;
 - (iii) the dates on which the area was cleared;
 - (iv) the area rehabilitated in hectares;
 - (v) the method of clearing; and
 - (vi) the purpose of clearing.
- b) The Permit Holder shall provide a report to the Director, Environment Division, Department of Industry and Resources by 30 June each year for the life of this permit, demonstrating adherence to all conditions of this permit, and setting out the records required under Condition 6 of this permit in relation to clearing carried out between 1 July and 30 June of the previous year.

Definitions

The following meanings are given to terms used in this Permit:

fill means material used to increase the ground level, or fill a hollow;

drainage line is a large channel (more than 8 metres in width) through which surface water naturally concentrates and flows, conveying water during or immediately after periods of rainfall.

gorge is a narrow cleft with steep, rocky walls through which water may flow during or immediately after periods of rainfall.


gully is a steep sided valley through which water may flow during or immediately after periods of rainfall.

mulch means the use of organic matter, woodchips or rocks to slow the movement of water across the soil surface and to reduce evaporation;

Priority Flora taxa means those plant taxa described as Priority Flora classes 1, 2, 3 or 4 in the *Declared Rare and Priority Flora List for Western Australia*, Department of Environment and Conservation, as amended;

road building materials means rock, gravel, soil, stone, timber, boulders and water;

weed means a species listed in Appendix 3 of the "Environmental Weed Strategy" published by the Department of Conservation and Land Management (1999), and plants declared under section 37 of the Agricultural and Related Resources Protection Act 1976.
