### PURPOSE FOR WHICH THE CLEARING MAY BE DONE

1. Clearing for the purpose of relocating an existing natural gas pipeline.

### CONDITIONS

1. The Permit Holder must not clear more than 28.7 hectares of native vegetation. All clearing must be within the area cross-hatched yellow on attached Plan 2485/1.

### Guiding Principles

2. In determining the amount of native vegetation to be cleared for the purpose of relocating an existing natural gas pipeline the Permit Holder must have regard to the following principles, set out in order of preference:
  - (i) avoid the clearing of native vegetation;
  - (ii) minimise the amount of native vegetation to be cleared; and
  - (iii) reduce the impact of clearing on any environmental value.

### Weed Management

3. When undertaking any clearing, revegetation and rehabilitation, or other activity pursuant to this Permit the Permit Holder must take the following steps to minimise the risk of the introduction and spread of weeds:
  - (i) clean earth-moving machinery of soil and vegetation prior to entering and leaving the area to be cleared;
  - (ii) ensure that no *weed-affected road building materials, mulch, fill* or other material is brought into the area to be cleared; and
  - (iii) restrict the movement of machines and other vehicles to the limits of the areas to be cleared.

### Fauna Management

4. The Permit Holder shall ensure that vehicles are excluded from undesignated tracks and off-road areas and shall not cause or permit vehicles to enter or remain within the above areas.

### Record Keeping

5. The Permit Holder shall record the following for each instance of clearing:
  - (i) the location of where the clearing occurred, expressed as grid coordinates using the Geocentric Datum of Australia 1994 coordinate system;
  - (ii) the size of the area cleared in hectares; the dates on which the area was cleared;
  - (iii) the purpose of clearing; and
  - (iv) the method of clearing.

### Reporting

6. The Permit Holder shall provide a report to the Director, Environment Division, Department of Industry and Resources by 31 July each year for the life of this permit, demonstrating adherence to all conditions of this permit, and setting out the records required under condition 5 of this permit in relation to clearing carried out between 1 July and 30 June of the previous financial year.

### Definitions


The following meanings are given to terms used in this Permit:

*fill* means material used to increase the ground level, or fill a hollow;

*mulch* means the use of organic matter, wood chips or rocks to slow the movement of water across the soil surface and to reduce evaporation;

*road building materials* means rock, gravel, soil, stone, timber, boulders and water;

*weed* means a species listed in Appendix 3 of the "Environmental Weed Strategy" published by the Department of Conservation and Land Management (1999), and plants declared under section 37 of the *Agricultural and Related Resources Protection Act 1976*;
