Granted under section 51E of the Environmental Protection Act 1986

BHP Billiton Iron Ore Pty Ltd

### LAND ON WHICH CLEARING IS TO BE DONE

Iron Ore (Mount Newman) Agreement Act 1964, Mineral Lease 244 SA (AML 70/244); General Purpose Lease 52/206; General Purpose Lease 52/214.

### PURPOSE FOR WHICH THE CLEARING MAY BE DONE

1. Clearing for the purposes of mineral production.

### CONDITIONS

1. The Permit Holder must not clear more than 21.32 hectares of native vegetation. All clearing must be within the areas cross-hatched yellow on attached Plans 2864/1A and 2864/1B.

# Avoid, minimise etc clearing

- 2. In determining the amount of native vegetation to be cleared authorised under this Permit, the Permit Holder must have regard to the following principles, set out in order of preference:
  - (i) avoid the clearing of native vegetation;
  - (ii) minimise the amount of native vegetation to be cleared; and
  - (iii) reduce the impact of clearing on any environmental value.

## Weed control

- 3. When undertaking any clearing or other activity authorised under this Permit, the Permit Holder must take the following steps to minimise the risk of the introduction and spread of *weeds*:
  - (i) clean earth-moving machinery of soil and vegetation prior to entering and leaving the area to be cleared;
  - (ii) ensure that no weed-affected *road building materials*, *mulch*, *fill* or other material is brought into the area to be cleared; and
  - (iii) restrict the movement of machines and other vehicles to the limits of the areas to be cleared.

## Record Keeping

- 4. The Permit Holder must maintain the following records for activities done pursuant to this Permit:
- (a) In relation to the clearing of native vegetation authorised under this Permit:
  - the location of where the clearing occurred, recorded using a Global Positioning System (GPS) unit set to Geocentric Datum Australia 1994 (GDA94), expressing the geographic coordinates in Easting and Northings;
  - (ii) the date that the area was cleared;
  - (iii) the size of the area cleared in hectares; and
  - (iv) the purpose for which clearing was undertaken.

Reporting

The Permit Holder shall provide a report to the Director, Environment Division, Department of Mines and Petroleum by 1 September each year for the life of this permit, demonstrating adherence to all conditions of this permit, and setting out the records required under Condition 4 of this permit in relation to the clearing carried out between 1 July and 30 June of the previous financial year.

## **DEFINITIONS**

The following meanings are given to terms used in this Permit:

fill means material used to increase the ground level, or fill a hollow;

mulch means the use of organic matter, wood chips or rocks to slow the movement of water across the soil surface and to reduce evaporation;

road building materials means rock, gravel, soil, stone, timber, boulders and water;

weed means a species listed in Appendix 3 of the "Environmental Weed Strategy" published by the Department of Conservation and Land Management (1999), and plants declared under section 37 of the Agricultural and Related Resources Protection Act 1976.
