## PURPOSE FOR WHICH THE CLEARING MAY BE DONE

1. Clearing for the purpose of railway construction and maintenance, and associated works.

### CONDITIONS

### **Authorised Activity**

1. The Permit Holder must not clear more than 295 hectares of native vegetation. All clearing must be within the area cross-hatched yellow on attached Plan 3547/1.

# Avoid, minimise etc clearing

- 2. In determining the amount of native vegetation to be cleared authorised under this Permit, the Permit Holder must have regard to the following principles, set out in order of preference:
  - (i) avoid the clearing of native vegetation;
  - (ii) minimise the amount of native vegetation to be cleared; and
  - (iii) reduce the impact of clearing on any environmental value.

## Period in which clearing is authorised

3. The Permit Holder shall not clear native vegetation unless commencing activities authorised under this permit within three months of the clearing being undertaken.

#### Weed control

- 4. When undertaking any clearing or other activity authorised under this Permit, the Permit Holder must take the following steps to minimise the risk of the introduction and spread of *weeds*:
  - (i) clean earth-moving machinery of soil and vegetation prior to entering and leaving the area to be cleared:
  - (ii) ensure that no *weed*-affected soil, *mulch*, *fill* or other material is brought into the area to be cleared; and
  - (iii) restrict the movement of machines and other vehicles to the limits of the areas to be cleared.

## Retain and spread vegetative material and topsoil

- 5. The Permit Holder shall:
  - (a) retain the vegetative material and topsoil removed by clearing authorised under this Permit and stockpile the vegetative material and topsoil in an area cross-hatched yellow on attached Plan 3547/1;
  - (b) within 18 months following clearing authorised under this permit, *revegetate* and *rehabilitate* the areas that are no longer required for the purpose for which they were cleared under this Permit by:
    - (i) ripping the ground on the contour to remove soil compaction; and
    - (ii) laying the vegetative material and topsoil retained under Condition 5(a);
  - (c) within 4 years of laying the vegetative material and topsoil on the cleared area in accordance with Condition 5(b) of this Permit:
    - (i) determine the species composition, structure and density of the area *revegetated* and *rehabilitated*; and
    - (ii) where, in the opinion of an *environmental specialist*, the composition structure and density determined under Condition 5(c)(i) of this Permit will not result in a similar species composition, structure and density to that of pre-clearing vegetation types in that area, *revegetate* the area by deliberately *planting* and/or *direct seeding* native vegetation that will result in a similar species composition, structure and density of native vegetation to pre-clearing vegetation types in that area and ensuring only *local provenance* seeds and propagating material are used.

## Records to be kept

- 6. The Permit Holder must maintain the following records for activities done pursuant to this Permit:
  - (a) In relation to the clearing of native vegetation authorised under this Permit:
    - the location where the clearing occurred, recorded using a Global Positioning System (GPS) unit set to Geocentric Datum Australia 1994 (GDA94), expressing the geographical coordinates in Eastings and Northings;
    - (ii) the date that the area was cleared;
    - (iii) the size of the area cleared (in hectares);
    - (iv) the purpose for which clearing was undertaken; and
    - (v) the date that railway construction and maintenance, and associated works ceased.
  - (b) In relation to the *revegetation* and *rehabilitation* of areas pursuant to Condition 5 of this Permit:
    - the location of any areas revegetated and rehabilitated, recorded using a Global Positioning System (GPS) unit set to Geocentric Datum Australia 1994 (GDA94), expressing the geographical coordinates in Eastings and Northings;
    - (ii) a description of the revegetation and rehabilitation activities undertaken;
    - (iii) the size of the area revegetated and rehabilitated (in hectares); and
    - (iv) the species composition, structure and density of revegetation and rehabilitation.

## Reporting

- 7. (a) The Permit Holder shall provide a report to the Director, Environment Division, Department of Mines and Petroleum by 1 September each year for the life of this permit, demonstrating adherence to all conditions of this permit, and setting out the records required under Condition 6 of this permit in relation to clearing carried out between 1 July and 30 June of the previous financial year.
  - (b) Prior to 3 April 2020, the Permit Holder must provide to the Director, Environment Division, Department of Mines and Petroleum a written report of records required under Condition 6 of this Permit where these records have not already been provided under Condition 7 (a) of this Permit.

#### **Definitions**

The following meanings are given to terms used in this Permit:

direct seeding means a method of re-establishing vegetation through the establishment of a seed bed and the introduction of seeds of the desired plant species;

environmental specialist means a person who is engaged by the Permit Holder for the purpose of providing environmental advice, who holds a tertiary qualification in environmental science or equivalent, and has experience relevant to the type of environmental advice that an environmental specialist is required to provide under this Permit;

fill means material used to increase the ground level, or fill a hollow;

*local provenance* means native vegetation seeds and propagating material from natural sources within 100 kilometres of the area cleared;

mulch means the use of organic matter, wood chips or rocks to slow the movement of water across the soil surface and to reduce evaporation;

planting means the re-establishment of vegetation by creating favourable soil conditions and planting seedlings of the desired species;

regenerate/ed/ion means revegetation that can be established from in situ seed banks contained either within the topsoil or seed-bearing mulch;

rehabilitate/ed/ion means actively managing an area containing native vegetation in order to improve the ecological function of that area;

revegetate/ed/ion means the re-establishment of a cover of local provenance native vegetation in an area using methods such as regeneration, direct seeding and/or planting, so that the species composition, structure and density is similar to pre-clearing vegetation types in that area;

weed/s means a species listed in Appendix 3 of the "Environmental Weed Strategy" published by the Department of Conservation and Land Management (1999), and plants declared under section 37 of the Agriculture and Related Resources Protection Act 1976.
