# PURPOSE FOR WHICH THE CLEARING MAY BE DONE

1. Clearing for the purposes of mineral production and associated activities.

# CONDITIONS

## Type of clearing authorised

1. The Permit Holder must not clear more than 67 hectares of native vegetation. All clearing must be within the area cross-hatched yellow on attached Plan 3958/2.

#### Avoid, minimise etc clearing

- 2. In determining the amount of native vegetation to be cleared authorised under this Permit, the Permit Holder must have regard to the following principles, set out in order of preference:
  - (i) avoid the clearing of native vegetation;
  - (ii) minimise the amount of native vegetation to be cleared; and
  - (iii) reduce the impact of clearing on any environmental value.

### Weed control

- 3. When undertaking any clearing or other activity authorised under this Permit, the Permit Holder must take the following steps to minimise the risk of the introduction and spread of weeds:
  - (i) clean earth-moving machinery of soil and vegetation prior to entering and leaving the area to be cleared;
  - (ii) ensure that no weed-affected soil, mulch, fill or other material is brought into the area to be cleared; and
  - (iii) restrict the movement of machines and other vehicles to the limits of the areas to be cleared.

#### Fauna Management

- 4. (a) Prior to undertaking any clearing authorised under this Permit, the area shall be inspected by a *fauna* specialist for the presence of *Leipoa ocellata* (Malleefowl) mounds.
  - (b) Where *Leipoa ocellata* (Malleefowl) mounds are identified in relation to Condition 4(a) of this Permit, the Permit Holder shall ensure that:
    - (i) all records of *Leipoa ocellata* (Malleefowl) mounds are submitted to the Executive Director, Environment, Department of Mines and Petroleum; and
    - (ii) no clearing occurs within 50 metres of the identified *Leipoa ocellata* (Malleefowl) mounds, unless approved by the *CEO*.

### Records to be kept

- 5. The Permit Holder must maintain the following records for activities done pursuant to this Permit:
  - (a) In relation to the clearing of native vegetation authorised under this Permit:
    - the location where the clearing occurred, recorded using a Global Positioning System (GPS) unit set to Geocentric Datum Australia 1994 (GDA94), expressing the geographical coordinates in Eastings and Northings;
    - (ii) the date that the area was cleared;
    - (iii) the size of the area cleared (in hectares); and
    - (iv) purpose for which clearing was undertaken.
  - (b) In relation to fauna management pursuant to Condition 4 of this Permit:
    - (i) the location of each *Leipoa ocellata* (Malleefowl) mound recorded using a Global Positioning System (GPS) unit set to Geocentric Datum Australia 1994 (GDA94), expressing the geographical coordinates in Eastings and Northings.

## Reporting

- 6. (a) The Permit Holder shall provide a report to the Executive Director, Environment, Department of Mines and Petroleum by 31 January each year for the life of this permit, demonstrating adherence to all conditions of this permit, and setting out the records required under Condition 5 of this permit in relation to clearing carried out between 1 January and 31 December of the previous calendar year.
  - (b) Prior to 30 December 2015, the Permit Holder must provide to the Executive Director, Environment, Department of Mines and Petroleum a written report of records required under Condition 5 of this Permit where these records have not already been provided under Condition 6(a) of this Permit.

# **Definitions**

The following meanings are given to terms used in this Permit:

CEO means the Chief Executive Officer of the Department of Environment and Conservation;

fauna specialist means a person with training and specific work experience in fauna identification or faunal assemblage surveys of Western Australian fauna;

fill means material used to increase the ground level, or fill a hollow;

mulch means the use of organic matter, wood chips or rocks to slow the movement of water across the soil surface and to reduce evaporation;

weed/s means a species listed in Appendix 3 of the "Environmental Weed Strategy" published by the Department of Conservation and Land Management (1999), and plants declared under section 37 of the Agriculture and Related Resources Protection Act 1976.
