

## **CLEARING PERMIT**

Granted under section 51E of the Environmental Protection Act 1986

**Purpose Permit number:** 4532/9

**Duration of Permit:** From 5 November 2011 to 5 November 2028

**Permit Holder:** Argyle Diamonds Limited

The Permit Holder is authorised to clear native vegetation subject to the following conditions of this Permit.

## PART I - CLEARING AUTHORISED

## 1. Land on which clearing is to be done

Diamond (Argyle Diamond Mines Joint Venture) Agreement Act 1981, Mining Lease 259SA (AM 70/259)

Mining Lease 80/114

Miscellaneous Licence 80/1

### 2. Purpose for which clearing may be done

Clearing for the purposes of mineral exploration, mineral production and associated activities.

#### 3. Area of Clearing

The Permit Holder must not clear more than 300 hectares of native vegetation. All clearing must be within the areas shaded yellow on attached Plan 4532/9.

## 4. Period in which clearing is authorised

The Permit Holder shall not clear any native vegetation after 5 November 2021.

## 5. Application

This Permit allows the Permit Holder to authorise persons, including employees, contractors and agents of the Permit Holder, to clear native vegetation for the purposes of this Permit subject to compliance with the conditions of this Permit and approval from the Permit Holder.

## PART II - MANAGEMENT CONDITIONS

#### 6. Weed Control

When undertaking any clearing or other activity authorised under this Permit, the Permit Holder must take the following steps to minimise the risk of the introduction and spread of *weeds*:

- (i) clean earth-moving machinery of soil and vegetation prior to entering and leaving the area to be cleared:
- (ii) ensure that no weed-affected soil, mulch, fill or other material is brought into the area to be cleared; and
- (iii) restrict the movement of machines and other vehicles to the limits of the areas to be cleared.

## 7. Retain and spread vegetative material and topsoil

The Permit Holder shall:

- (a) retain the vegetative material and topsoil removed by clearing authorised under this Permit and stockpile the vegetative material and topsoil within an area that has already been cleared.
- (b) within 12 months following clearing authorised under this permit, revegetate and rehabilitate the areas that are no longer required for the purpose for which they were cleared under this Permit by:
  - re-shaping the surface of the land so that it is consistent with the surrounding 5 metres of uncleared land:
  - (ii) ripping the ground on the contour to remove soil compaction; and
  - (iii) laying the vegetative material and topsoil retained under Condition 7(a) on the cleared
- (c) within 4 years of laying the vegetative material and topsoil on the cleared area in accordance with Condition 7(b) of this Permit:
  - (i) engage an *environmental specialist* to determine the species composition, structure and density of the area *revegetated* and *rehabilitated*; and
  - (ii) where, in the opinion of an *environmental specialist*, the composition, structure and density determined under Condition 7(c)(i) of this Permit will not result in a similar species composition, structure and density to that of pre-clearing vegetation types in that area, *revegetate* the area by deliberately *planting* and/or *direct seeding* native vegetation that will result in a similar species composition, structure and density of native vegetation to pre-clearing vegetation types in that area and ensuring only *local provenance* seeds and propagating material are used.
- (d) Where additional planting or direct seeding of native vegetation is undertaken in accordance with Condition 7(c)(ii) of this permit, the Permit Holder shall repeat Condition 7(c)(i) and 7(c)(ii) within 24 months of undertaking the additional planting or direct seeding of native vegetation.
- (e) Where a determination by an *environmental specialist* that the composition, structure and density within areas *revegetated* and *rehabilitated* will result in a similar species composition, structure and density to that of pre-clearing vegetation types in that area, as determined in Condition 7(c)(i) and 7(c)(ii) of this permit, that determination shall be submitted for the *CEO*'s consideration. If the CEO does not agree with the determination made under Condition 7(c)(ii), the *CEO* may require the Permit Holder to undertake additional *planting* and *direct seeding* in accordance with the requirements under Condition 7(c)(ii).

# 8. Retain vegetative material and topsoil, revegetation and rehabilitation

- (a) The Permit Holder shall *revegetate* and *rehabilitate* 67.59 hectares of *temporary disturbance* previously cleared within the area shaded yellow on attached Plan 4532/9 by:
  - (i) laying vegetative material and topsoil previously retained within the area shaded yellow on attached Plan 4532/9 on the cleared areas;
  - (ii) ripping the ground on the contour to remove soil compaction;
  - (iii) re-shaping the surface of the land so that it is consistent with the surrounding 5 metres of uncleared land;
- (b) Within 4 years of undertaking *revegetation* and *rehabilitation* in accordance with Condition 8(a) of this Permit:
  - (i) engage an *environmental specialist* to determine the species composition, structure and density of the area *revegetated* and *rehabilitated*; and
  - (ii) where, in the opinion of an *environmental specialist*, the composition structure and density determined under Condition 8(b)(i) of this Permit will not result in a similar species composition, structure and density to that of pre-clearing vegetation types in that area, *revegetate* the area by deliberately *planting* and/or *direct seeding* native vegetation that will

result in a similar species composition, structure and density of native vegetation to preclearing vegetation types in that area and ensuring only *local provenance* seeds and propagating material are used.

- (c) Where additional *planting* or *direct seeding* of native vegetation is undertaken in accordance with Condition 8(b)(ii) of this permit, the Permit Holder shall repeat Condition 8(b)(i) and 8(b)(ii) within 24 months of undertaking the additional *planting* or *direct seeding* of native vegetation.
- (d) Where a determination by an *environmental specialist* that the composition, structure and density within areas *revegetated* and *rehabilitated* will result in a similar species composition, structure and density to that of pre-clearing vegetation types in that area, as determined in Condition 8(b)(i) and 8(b)(ii) of this permit, that determination shall be submitted for the *CEO*'s consideration. If the *CEO* does not agree with the determination made under Condition 8(b)(ii), the *CEO* may require the Permit Holder to undertake additional *planting* and *direct seeding* in accordance with the requirements under Condition 8(b)(ii).

#### PART III - RECORD KEEPING AND REPORTING

#### 9. Records to be kept

The Permit Holder must maintain the following records for activities done pursuant to this Permit:

- (a) In relation to the clearing of native vegetation authorised under this Permit,
  - (i) the location where the clearing occurred, recorded using a Global Positioning System (GPS) unit set to Geocentric Datum Australia 1994 (GDA94), expressing the geographical coordinates in Eastings and Northings or decimal degrees;
  - (ii) the date that the area was cleared;
  - (iii) the size of the area cleared (in hectares); and
  - (iv) purpose for which clearing was undertaken.
- (b) In relation to the *revegetation* and *rehabilitation* of areas pursuant to Conditions 7 and 8 of this Permit:
  - (i) the location of any areas *revegetated* and *rehabilitated*, recorded using a Global Positioning System (GPS) unit set to Geocentric Datum Australia 1994 (GDA94), expressing the geographical coordinates in Eastings and Northings or decimal degrees;
  - (ii) a description of the *revegetation* and *rehabilitation* activities undertaken; and the size of the area *revegetated* and *rehabilitated* (in hectares).

#### 10. Reporting

- (a) The Permit Holder shall provide a report to the Director Operations, Resource and Environmental Compliance Division, Department of Mines, Industry Regulation and Safety by 30 September each year for the life of this permit, demonstrating adherence to all conditions of this permit, and setting out the records required under Condition 9 of this permit in relation to clearing carried out between 1 July and 30 June of the previous financial year.
- (b) Prior to 5 November 2028, the Permit Holder must provide to the Director Operations, Resource and Environmental Compliance Division, Department of Mines, Industry Regulation and Safety a written report of records required under Condition 9 of this Permit where these records have not already been provided under Condition 10(a) of this Permit.

#### **DEFINITIONS**

The following meanings are given to terms used in this Permit:

CEO means the Chief Executive Officer of the Department of Water and Environmental Regulation or an Officer with delegated authority under Section 20 of the Environmental Protection Act 1986;

direct seeding means a method of re-establishing vegetation through the establishment of a seed bed and the introduction of seeds of the desired plant species;

environmental specialist means a person who holds a tertiary qualification in environmental science or equivalent, and has experience relevant to the type of environmental advice that an environmental specialist is required to provide under this Permit, or who is approved by the *CEO* as a suitable environmental specialist;

fill means material used to increase the ground level, or fill a hollow;

*local provenance* means native vegetation seeds and propagating material from natural sources within 100 kilometres and the same Interim Biogeographic Regionalisation for Australia (IBRA) subregion of the area cleared:

*mulch* means the use of organic matter, wood chips or rocks to slow the movement of water across the soil surface and to reduce evaporation;

planting means the re-establishment of vegetation by creating favourable soil conditions and planting seedlings of the desired species;

regenerate/ed/ion means re-establishment of vegetation from in situ seed banks and propagating material (such as lignotubers, bulbs, rhizomes) contained either within the topsoil or seed-bearing *mulch*;

rehabilitate/ed/ion means actively managing an area containing native vegetation in order to improve the ecological function of that area;

revegetate/ed/ion means the re-establishment of a cover of local provenance native vegetation in an area using methods such as regeneration, direct seeding and/or planting, so that the species composition, structure and density is similar to pre-clearing vegetation types in that area;

*temporary disturbance* means areas cleared for the purpose of mineral exploration; construction and maintenance of access roads; fibre optic cables; maintenance activities; geotechnical investigations; borrow pits; laydown areas; assembly areas; water bores; turkey nests; culverts; and ancillary infrastructure;

weed/s means any plant -

- (a) that is a declared pest under section 22 of the Biosecurity and Agriculture Management Act 2007; or
- (b) published in a Department of Biodiversity, Conservation and Attractions Regional Weed Rankings Summary, regardless of ranking; or
- (c) not indigenous to the area concerned.
