Ownership of Land

If granted, the permit will be issued in the name of the landowner (or applicant if acting on behalf of the landowner).

A landowner can be:

- · A person who holds the Certificate of Title:
- A person who is the lessee of Crown land, or
- A public authority that is responsible for care of the land
