Part 3 Applicant

To apply for a permit you must either

- · the landowner;
- · acting on the landowner's behalf;
- · likely to become the landowner.

Note: If you are acting on behalf of the landowner, you must attach a letter of authority from the landowner explicitly stating that you, the applicant, has authority to clear on the said land.

Ownership of Land

If granted, the permit will be the name of the issued in landowner (or applicant if acting on behalf of the landowner).

A landowner can be:

- · A person who holds the Certificate of Title;
- · A person who is the lessee of Crown land, or
- A public authority that is responsible for care of the land.

Total area of clearing proposed (Hectares)

and/or number of individual trees to be removed 12 000 over-storey stems across 20 hectares.

Proposed method of clearing

The method of clearing will be agreed upon in consultation with the DEC - options are stem injection using "round-up" or chain saw individual tagged trees.

Period within which clearing is proposed to be undertaken, e.g. May 2010 - June 2010

Purpose of clearing

In order to achieve the conditions set out in Ministerial Statement 604, review of the project rehabilitation site has identified the need for thinning. Reduction in tree stand density to an average of 8 over-storey stems per 100m2 (plants >5m high) and increase the under-storey planting (both seedling and direct seeding). An estimated 12, 000 over-storey stems across the approximate 20 ha rehabilitation area.
