The Permit Holder is authorised to clear native vegetation subject to the following conditions of this Permit.

# PART I-CLEARING AUTHORISED

# 1. Purpose for which clearing may be done

Clearing for the purpose of constructing a fence.

# 2. Land on which clearing is to be done

Part Lot 77 on Deposited Plan 220192 (Rocklea 6751).

#### 3. Area of Clearing

The Permit Holder must not clear more than 9.7 hectares of native vegetation within the area shaded yellow on attached Plan 4825/2.

# 4. Application

This Permit allows the Permit Holder to authorise persons, including employees, contractors and agents of the Permit Holder, to clear native vegetation for the purposes of this Permit subject to compliance with the conditions of this Permit and approval from the Permit Holder.

# 5. Type of clearing authorised

This Permit authorises the Permit Holder to clear native vegetation for activities to the extent that the Permit Holder has the power to clear native vegetation for those activities under the *Land Administration Act 1997* or any other written law.

#### 6. Compliance with Assessment Sequence and Management Procedures

Prior to clearing any native vegetation under conditions 1, 2 and 3 of this Permit, the Permit Holder must comply with the Assessment Sequence and the Management Procedures set out in Part II of this Permit.

# PART II - ASSESSMENT SEQUENCE AND MANAGEMENT PROCEDURES

#### 7. Avoid, minimise etc clearing

In determining the amount of native vegetation to be cleared authorised under this Permit, the Permit Holder must have regard to the following principles, set out in order of preference:

- (a) avoid the clearing of native vegetation;
- (b) minimise the amount of native vegetation to be cleared; and
- (c) reduce the impact of clearing on any environmental value.

# 8. Weed control

When undertaking any clearing or other activity authorised under this Permit, the Permit Holder must take the following steps to minimise the risk of the introduction and spread of weeds:

- (a) clean earth-moving machinery of soil and vegetation prior to entering and leaving the area to be cleared;
- (b) ensure that no weed-affected soil, mulch, fill or other material is brought into the area to be cleared; and
- (c) restrict the movement of machines and other vehicles to the limits of the areas to be cleared.

#### 9. Watercourse

- (a) Where practicable the Permit Holder shall avoid clearing riparian vegetation.
- (b) Where a watercourse is to be impacted by clearing, the Permit Holder shall maintain the existing surface flow of that watercourse by use of culverts.

#### PART III - RECORD KEEPING AND REPORTING

#### 10. Records must be kept

The Permit Holder must maintain the following records in relation to the clearing of native vegetation authorised under this Permit:

- (a) the location where the clearing occurred, recorded using a Global Positioning System (GPS)
  unit set to Geocentric Datum Australia 1994 (GDA94), expressing the geographical coordinates
  in Eastings and Northings or decimal degrees;
- (b) the date that the area was cleared; and
- (c) the size of the area cleared (in hectares).

#### 11. Reporting

- (a) The Permit Holder must provide to the CEO on or before 30 June of each year, a written report:
  - (i) of records required under condition 10 of this Permit; and
  - (ii) concerning activities done by the Permit Holder under this Permit between 1 January and 31 December of the preceding year.
- (b) Prior to 9 January 2017, the Permit Holder must provide to the CEO a written report of records required under condition 10 of this Permit where these records have not already been provided under condition 11(a) of this Permit.

# DEFINITIONS

The following meanings are given to terms used in this Permit:

fill means material used to increase the ground level, or fill a hollow;

*mulch* means the use of organic matter, wood chips or rocks to slow the movement of water across the soil surface and to reduce evaporation;

weed/s means any plant -

andend

- (a) that is a declared pest under section 22 of the Biosecurity and Agriculture Management Act 2007; or
- (b) published in the Department of Environment and Conservation Regional Weed Assessments, regardless of ranking; or
- (c) not indigenous to the area concerned.




Areas Approved to Clear

#### 2. Site Information

#### Existing environment and information

#### 2.1.1. Description of the native vegetation under application

#### Vegetation Description

Mapped Beard vegetation association 567 is described as Hummock grasslands, shrub steppe; mulga & kanji over soft spinifex & Triodia basedowii (Shepherd et al 2001).

#### Clearing Description

The application is to clear up to 9.7 hectares of native vegetation within Part Lot 77 on Plan 220192 (CL3114 1166), Rocklea for the purpose of fence construction. The vegetation is in very (Keighery 1994) condition.

#### Vegetation Condition

Good: Vegetation structure altered; obvious signs of disturbance (Keighery 1994)

#### Comment

condition of the vegetation was determined through aerial imagery (Rocklea 50cm Orthomosaic - Landgate 2004).

#### 3. Assessment of application against clearing principles

#### Comments

The application is to expand the clearing footprint by 0.1 hectares, from 9.6 to 9.7 hectares within Lot 77 on Plan 220192, Rocklea, for the purpose of constructing a fence.

A review of current environmental information reveals no new additional information. Therefore, the assessment against the clearing principles has not changed and can be found in the Clearing Permit Decision Report CPS 4825/1.

#### Comments

The application is to clear up to 9.7 hectares of native vegetation within Part Lot 77 on Plan 220192 (CL3114 1166), Rocklea for the purpose of fence construction. The construction of the fence line is required to keep livestock out of the White Quartz Cultural camp which belongs to the local traditional owner group (Hamersley 2012).

The area under application falls within the Pilbara Groundwater and Surface Water area which are areas proclaimed under the Rights in Water and Irrigation (RIWI) Act 1914. The applicant has obtained a permit to Obstruct or Interfere under the RIWI Act 1914 from the Department of Water for works within the watercourses (Hamersley 2012).
