Environmental Protection Act 1986, section 51KA

The clearing of native vegetation is prohibited in Western Australia unless a clearing permit has been granted for the clearing or where a permit is not required (either due to a referral determination that one is not needed or because an exemption applies). A person who causes or allows unauthorised clearing commits an offence.




It was determined that a number of road and intersection upgrades would be required to improve safety and serviceability of the haulage route for both Atlas Iron road trains and other road users, including upgrading of the current Abydos mine haul road and Marble Bar intersection, to allow road trains to safely travel between Sanjiv Ridge mine (formerly the Corunna Downs Project) and Abydos mine sites. To date clearing works have not been completed under CPS 5176/3. However, upgrades associated with the permit are still planned. As CPS 5176/3 is due to expire on the 28 September 2023, Atlas Iron is applying to extend the duration of the permit to 28 September 2028. The amount of clearing authorised and the clearing permit boundary remains the same as the currently approved CPS 5176/3.</p>
