



CLEARING PERMIT

Granted under section 51E of the Environmental Protection Act 1986

Duration of Permit:	From 9 November 2012 to 9 November 2017

The Permit Holder is authorised to clear native vegetation subject to the following conditions of this Permit.

PART I – CLEARING AUTHORISED

1. Purpose for which clearing may be done

Clearing for the purpose of constructing transmission line infrastructure and installing underground fibre optic cables.

3. Area of Clearing

The Permit Holder must not clear more than 21 hectares of native vegetation within the area shaded yellow on attached Plan 5261/2.

4. Application

This Permit allows the Permit Holder to authorise persons, including employees, contractors and agents of the Permit Holder, to clear native vegetation for the purposes of this Permit subject to compliance with the conditions of this Permit and approval from the Permit Holder.

5. Type of clearing authorised

This Permit authorises the Permit Holder to clear native vegetation for activities to the extent that the Permit Holder has the power to clear native vegetation for those activities under the *Energy Operators (Powers) Act 1979* or any other written law.

PART II – ASSESSMENT SEQUENCE AND MANAGEMENT PROCEDURES

6. Avoid, minimise etc clearing

In determining the amount of native vegetation to be cleared authorised under this Permit, the Permit Holder must have regard to the following principles, set out in order of preference:

- avoid the clearing of native vegetation;
- minimise the amount of native vegetation to be cleared; and
- reduce the impact of clearing on any environmental value.

7. Weed control

When undertaking any clearing or other activity authorised under this Permit, the Permit Holder must take the following steps to minimise the risk of the introduction and spread of *weeds*:

- (a) clean earth-moving machinery of soil and vegetation prior to entering and leaving the area to be cleared;
- (b) ensure that no *weed*-affected soil, *mulch*, *fill* or other material is brought into the area to be cleared; and
- (c) restrict the movement of machines and other vehicles to the limits of the areas to be cleared.


DEFINITIONS

The following meanings are given to terms used in this Permit:

fill means material used to increase the ground level, or fill a hollow;

mulch means the use of organic matter, wood chips or rocks to slow the movement of water across the soil surface and to reduce evaporation;

weed/s means a species listed in Appendix 3 of the "Environmental Weed Strategy" published by the Department of Conservation and Land Management (1999), and plants declared under section 37 of the *Agriculture and Related Resources Protection Act 1976*.

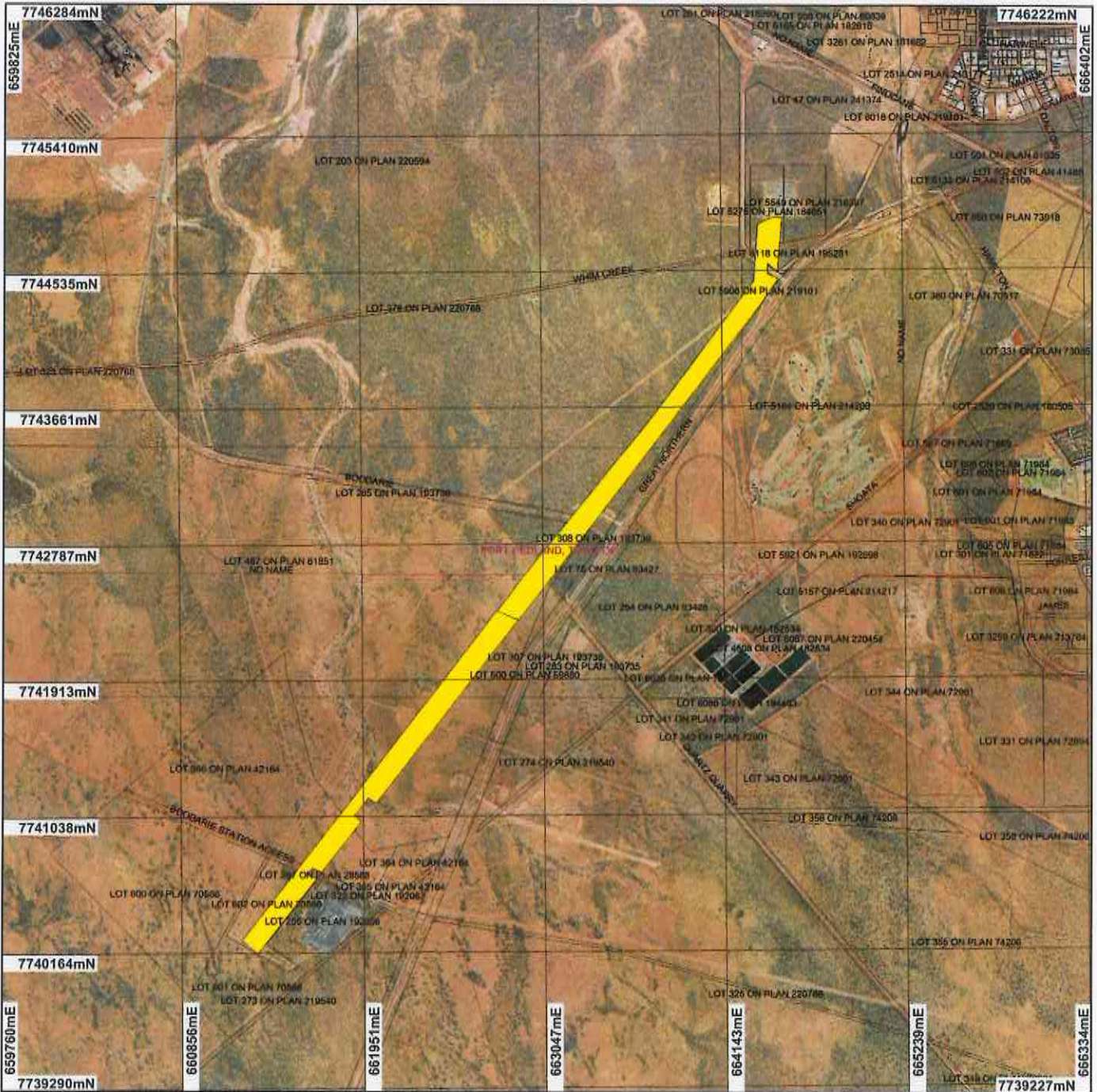

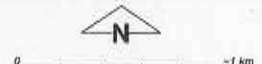

2.1. Existing environment and information

2.1.1. Description of the native vegetation under application

Mapped Beard vegetation association 589 is described as short bunch grassland of savanna, grass plain (Pilbara), hummock grasslands and grass steppe with soft spinifex (Shepherd et al, 2001).	This application proposes to clear 21 hectares of native vegetation within multiple Lots, Boodarie, for the purpose of constructing 20 steel towers, underground fibre optic cable and access points to provide for ongoing maintenance of the transmission line. Vegetation will be cleared primarily by mechanical methods.	Excellent: Vegetation structure intact; disturbance affecting individual species, weeds non-aggressive (Keighery 1994)	The condition of the vegetation was established through a survey of the application area undertaken by Strategen (2012).
Mapped Beard vegetation association 647 is described as hummock grasslands, dwarf-shrub steppe with <i>Acacia translucens</i> over soft spinifex (Shepherd et al, 2001).	The application area is predominantly composed of two vegetation types. Sandplain B consists of low <i>Acacia stellaticeps</i> shrublands over <i>Triodia epactia</i> and <i>Triodia secunda</i> hummock grasslands, Tussock grassland of <i>Eragrostis</i> sp. over <i>Triodia</i> spp., Hummock grassland of <i>Triodia</i> spp. and closed heathland. Sandplain C consists of closed heath of <i>Acacia stellaticeps</i> over <i>Triodia</i> spp. and hummock grassland of <i>Triodia</i> spp. with <i>Ptilotus obovatus</i> (Strategen, 2012).	To Completely Degraded: No longer intact; completely/almost completely without native species (Keighery 1994)	

3. Assessment of application against clearing principles

Comments

The proponent has applied to increase the clearing footprint and the area to be cleared by one hectare, giving a total proposed clearing of 21 hectares, for the purpose of constructing 20 steel towers, underground fibre optic cables and access points to provide for ongoing maintenance of the transmission line. A review of current environmental information reveals no new additional information. Therefore the assessment against the clearing principles has not changed and can be found in the Clearing Permit Decision Report CPS 5261/1.
