Application for an amendment to a clearing permit

Environmental Protection Act 1986 s 51M

FORM C4

Clearing of native vegetation is prohibited in Western Australia except where a clearing permit has been granted or an exemption applies. A person who causes or allows unauthorised clearing commits an offence.

The land description is to be changed to Mining Lease M 39/1116. Mining Lease M 39/1116 was granted on 19 July 2017 and is an amalgamation of several mining leases including those CPS 5898/1 was originally granted on (M 39/366, M 39/374, M 39/375 and M 39/499), for which conditional surrenders have been recorded. No change is proposed to the location or area of clearing. Only the underlying tenure has changed.

Mining Lease 39/1116 is solely held by AngloGold Ashanti Australia Ltd as were the original tenements so there is no change in ownership.

It is also requested that the period of the validity of the permit be extended to 1 August 2022.
