



Application for a clearing permit (purpose permit)

Environmental Protection Act 1986 s 51E

FORM C2

Clearing of native vegetation is prohibited in Western Australia except where a clearing permit has been granted or an exemption applies. A person who causes or allows unauthorised clearing commits an offence.

Bowelling Duranillin Rd.at Gibbs Rd.intersection is poor sight lines at intersection. 1 tree & 2 shrubs req.
Bowelling Duranillin clearing for 2013-14 works is road reconstruction and widening. 2m x 1.2km.
Capercup South West Rd. is widening to 8m& drain improvement. 10 Trees req.
Horley Rd. is poor sight lines on a bend (school bus route) 2 trees req.
Howie Rd. is widening and gravel improvement 2m X 1km

Part 3 Applicant

To apply for a permit you must either be:

- the landowner; or
- have the authority of the landowner to access the land and undertake the clearing.

If granted, the permit will be issued in the name of the applicant.
