



# Application for a clearing permit (purpose permit)

Environmental Protection Act 1986 s 51E

## FORM C2

Clearing of native vegetation is prohibited in Western Australia except where a clearing permit has been granted or an exemption applies. A person who causes or allows unauthorised clearing commits an offence.

Manual removal of trees Chainsaw/ stumps removed with excavator. Pruning of vegetation in preference to removal where ever possible.

Purpose of clearing

Road widening program associated with Black Spot funding. Realignment of road is required to improve road design and improve line of sight and overall safety for road users. Clearing required to straighten substandard corners and road width. Associated works will improve drainage and allow improved road stability. Part of the proposed work area was originally included in an expired clearing permit (CPS 181/3). However only a small section of the reserve was clearing under this permit. Flora Survey for the proposed work area has been undertaken by qualified Flora Specialist in September 2013. - No significant/rare vegetation found in the propose work area.

### Part 3 Applicant

- have the authority of the landowner to access the land and undertake the clearing.

If granted, the permit will be issued in the name of the applicant.
