2. Site Information

2.1. Existing environment and information

2.1.1. Description of the native vegetation under application

Vegetation Description

Beard vegetation associations have been mapped for the whole of Western Australia and are useful to look at vegetation in a regional context. Two Beard vegetation associations were mapped within the application area (GIS Database):

Beard Vegetation Association 509: Succulent steppe with woodland; gimlet & saltbush; and

Beard Vegetation Association 676: Succulent steppe; samphire.

A database search for threatened flora, followed by a site assessment of the vegetation and a targeted search for Threatened flora identified in database searches was undertaken by Jeremy Shepherdson of Ecotec (WA) Pty Ltd in April 2017 (Alliance Mineral Assets, 2017). The following vegetation association was recorded within the application area:

 Very open shrubland of Maireana brevifolia and M. sedifolia over various herbaceous and annual species

Scattered individual *Acacia tetragonophylla*, *Atriplex nummularia* and small stands of Eucalyptus (*E. griffithsii*, *E. flocktoniae*, *E. oleosa*) are also found throughout the area.

Clearing Description

Bald Hill Tantalite Project

Alliance Mineral Assets Ltd is proposing to clear up to 258 hectares of native vegetation, within a total boundary of approximately 502 hectares, for the purpose of mineral production. The proposed clearing is located approximately 58 kilometres south east of Kambalda, in the Shire of Coolgardie.

Vegetation Condition

Degraded: Structure severely disturbed; regeneration to good condition requires intensive management (Keighery, 1994).

Comment

The vegetation condition was derived from a vegetation survey conducted by Jeremy Shepherdson of Ecotec (WA) Pty Ltd (Alliance Mineral Assets, 2017).

Clearing permit CPS 6131/1 was granted by the Department of Mines and Petroleum (DMP) on 21 August 2014 and authorised the clearing of up to 30.1 hectares of native vegetation within a boundary of approximately 502 hectares. The clearing allowed for the recommencement of mining operations at the site.

CPS 6131/1 was amended on 26 November 2015, for the purpose of increasing the amount of approved clearing from 30.1 hectares to 70.1 hectares. The permit boundary was not changed.

The permit holder has applied to amend CPS 6131/2 to increase the amount of approved clearing from 70.1 hectares to 258 hectares, and to update the tenure. The permit boundary has not changed.

3. Assessment of application against Clearing Principles

Comments

Alliance Mineral Assets Ltd has applied to increase the amount of clearing by 187.9 hectares and to update the General Pupose Lease tenure from G15/17 to G15/28. The total amount of clearing will increase from 70.1 hectares to 258 hectares; however the clearing permit boundary will remain the same. The environmental values of the entire clearing permit boundary (502 hectares) were assessed under clearing permit CPS 6131/1 and CPS 6131/2, and no significant environmental issues were identified. The majority of the vegetation to be cleared is in a 'Degraded' condition (Keighery, 1994) and is very sparse throughout the application area (GIS Database).

A search of current available databases confirmed that no Threatened or Priority flora species are likely to be impacted by the proposed amendment (DPaW, 2017; GIS Database). Records show that two Priority 3 flora species and three Priority 4 flora species are known within a 20 kilometre radius (local area) of the application area (DPaW, 2017). The soils mapped over the application area are described as neutral red earths with a variable content of ironstone gravel (GIS Database; Northcote et al. 1960-68). Of the Priority flora species known from the local area, suitable habitat may be present for *Calytrix plumulosa* (P3) and *Lepidosperma lyonsii* (P4), though it is considered unlikely that the proposed clearing will impact on the conservation status of these flora species should they be present within the application area.

There are no known Threatened Ecological Communities (TECs) or Priority Ecological Communities (PECs) within 200 kilometres of the application area. Ecotec (WA) Pty Ltd did not identify any TECs or PECs during a site inspection of the application area (Alliance Mineral Assets, 2017).

According to available records, the only fauna species of conservation significance known from the local area is the Malleefowl (*Leipoa ocellata*) (DPaW, 2017). Given that the application area lacks abundant leaf letter used for the construction of nesting mounds (GIS Database; DotE, 2017), it is unlikely to represent significant habitat for Malleefowl. Much of the application area has been disturbed by previous mining and exploration, as well as historical removal of timber and overgrazing by stock (Alliance Mineral Assets, 2017). The vegetation that remains within the clearing permit boundary is very patchy and sparse (Alliance Mineral Assets, 2017; GIS Database). Large amounts of better quality vegetation is present throughout the local area and region, therefore impacts to local fauna species are expected to be minimal.

There are no conservation areas within 40 kilometres of the application area and the Beard vegetation associations mapped for the site (Beard associations 509 and 676) are well represented, with over 95% of their pre-European extent remaining within the state and bioregion (Government of Western Australia, 2015).

Two introduced flora species have been recorded within the application area; *Carthamus lanatus* (Saffron Thistle) and *Citrullus lanatus* (Paddy melon) (Alliance Mineral Assets, 2017). Clearing activities have the potential to result in an increase in the incidence of weed species, which may negatively impact on the biodiversity of the local area. Potential impacts to biodiversity as a result of the proposed clearing may be minimised by the implementation of the existing weed management condition.

There are two minor, non-perennial watercourses that intersect the application area (GIS Database). Ecotec (WA) Pty Ltd (Alliance Mineral Assets, 2017) did not observe any district vegetation growing in association with these drainage lines. While riparian vegetation may be absent, the clearing of native vegetation in or around watercourses has the potential to impact surface water flows and sediment loads. Potential impacts to watercourses as a result of the proposed clearing may be minimised by the implementation of a watercourse/vegetation management condition.

Given the local climate of the region (low rainfall and high evaporation), the proposed clearing of an additional 187.9 hectares of sparse, predominately degraded vegetation, is unlikely to result in an increased risk of flooding or significant land degradation issues (BoM, 2017; GIS Database). Due to existing hyper-saline groundwater conditions, adverse impacts to groundwater quality are also considered unlikely (GIS Database).

The amendment application has been assessed against the clearing principles, planning instruments and other matters in accordance with s.51O of the Environmental Protection Act 1986, and the proposed clearing may be at variance to Principle (f), is not likely to be at variance to Principles (a), (b), (c), (g), (h), (i) and (j) and is not at variance to Principle (d) and (e).

Comments

There is one Native Title Claim (WC1999/002) over the application area (Department of Planning, Lands and Heritage, 2017). This claim has been registered with the National Native Title Tribunal on behalf of the claimant group. However, the tenure has been granted in accordance with the future act regime of the *Native Title Act 1993* and the nature of the act (i.e. the proposed clearing activity) has been provided for in that process, therefore the granting of a clearing permit is not a future act under the *Native Title Act 1993*.

There are no registered Sites of Aboriginal Significance located in the application area (Department of Planning, Lands and Heritage, 2017). It is the proponent's responsibility to comply with the *Aboriginal Heritage Act 1972* and ensure that no Sites of Aboriginal Significance are damaged through the clearing process.

It is the proponent's responsibility to liaise with the Department of Water and Environmental Regulation and the Department of Biodiversity Conservation and Attractions, to determine whether a Works Approval, Water Licence, Bed and Banks Permit, or any other licences or approvals are required for the proposed works.

The amendment application was advertised on 9 October 2017 by the Department of Mines and Petroleum inviting submissions from the public. No submissions were received in relation to this application.

T Threatened species:

Published as Specially Protected under the *Wildlife Conservation Act 1950*, listed under Schedules 1 to 4 of the Wildlife Conservation (Specially Protected Fauna) Notice for Threatened Fauna and Wildlife Conservation (Rare Flora) Notice for Threatened Flora (which may also be referred to as Declared Rare Flora).

Threatened fauna is that subset of 'Specially Protected Fauna' declared to be 'likely to become extinct' pursuant to section 14(4) of the *Wildlife Conservation Act 1950*.

Threatened flora is flora that has been declared to be 'likely to become extinct or is rare, or otherwise in need of special protection', pursuant to section 23F(2) of the *Wildlife Conservation Act 1950*.

The assessment of the conservation status of these species is based on their national extent and ranked according to their level of threat using IUCN Red List categories and criteria as detailed below.

CR Critically endangered species

Threatened species considered to be facing an extremely high risk of extinction in the wild. Published as Specially Protected under the *Wildlife Conservation Act 1950*, in Schedule 1 of the Wildlife Conservation (Specially Protected Fauna) Notice for Threatened Fauna and Wildlife Conservation (Rare Flora) Notice for Threatened Flora.

EN Endangered species

Threatened species considered to be facing a very high risk of extinction in the wild. Published as Specially Protected under the *Wildlife Conservation Act 1950*, in Schedule 2 of the Wildlife Conservation (Specially Protected Fauna) Notice for Threatened Fauna and Wildlife Conservation (Rare Flora) Notice for Threatened Flora.

VU Vulnerable species

Threatened species considered to be facing a high risk of extinction in the wild. Published as Specially Protected under the *Wildlife Conservation Act 1950*, in Schedule 3 of the Wildlife Conservation (Specially Protected Fauna) Notice for Threatened Fauna and Wildlife Conservation (Rare Flora) Notice for Threatened Flora.

EX Presumed extinct species

Species which have been adequately searched for and there is no reasonable doubt that the last individual has died. Published as Specially Protected under the *Wildlife Conservation Act 1950*, in Schedule 4 of the Wildlife Conservation (Specially Protected Fauna) Notice for Presumed Extinct Fauna and Wildlife Conservation (Rare Flora) Notice for Presumed Extinct Flora.

IA Migratory birds protected under an international agreement

Birds that are subject to an agreement between the government of Australia and the governments of Japan (JAMBA), China (CAMBA) and The Republic of Korea (ROKAMBA), and the Bonn Convention, relating to the protection of migratory birds. Published as Specially Protected under the *Wildlife Conservation Act 1950*, in Schedule 5 of the Wildlife Conservation (Specially Protected Fauna) Notice.

CD Conservation dependent fauna

Fauna of special conservation need being species dependent on ongoing conservation intervention to prevent it becoming eligible for listing as threatened. Published as Specially Protected under the

Wildlife Conservation Act 1950, in Schedule 6 of the Wildlife Conservation (Specially Protected Fauna) Notice.

OS Other specially protected fauna

Fauna otherwise in need of special protection to ensure their conservation. Published as Specially Protected under the *Wildlife Conservation Act 1950*, in Schedule 7 of the Wildlife Conservation (Specially Protected Fauna) Notice.

P Priority species

Species which are poorly known; or

Species that are adequately known, are rare but not threatened, and require regular monitoring. Assessment of Priority codes is based on the Western Australian distribution of the species, unless the distribution in WA is part of a contiguous population extending into adjacent States, as defined by the known spread of locations.

P1 Priority One - Poorly-known species:

Species that are known from one or a few locations (generally five or less) which are potentially at risk. All occurrences are either: very small; or on lands not managed for conservation, e.g. agricultural or pastoral lands, urban areas, road and rail reserves, gravel reserves and active mineral leases; or otherwise under threat of habitat destruction or degradation. Species may be included if they are comparatively well known from one or more locations but do not meet adequacy of survey requirements and appear to be under immediate threat from known threatening processes. Such species are in urgent need of further survey.

P2 Priority Two - Poorly-known species:

Species that are known from one or a few locations (generally five or less), some of which are on lands managed primarily for nature conservation, e.g. national parks, conservation parks, nature reserves and other lands with secure tenure being managed for conservation. Species may be included if they are comparatively well known from one or more locations but do not meet adequacy of survey requirements and appear to be under threat from known threatening processes. Such species are in urgent need of further survey.

P3 Priority Three - Poorly-known species:

Species that are known from several locations, and the species does not appear to be under imminent threat, or from few but widespread locations with either large population size or significant remaining areas of apparently suitable habitat, much of it not under imminent threat. Species may be included if they are comparatively well known from several locations but do not meet adequacy of survey requirements and known threatening processes exist that could affect them. Such species are in need of further survey.

P4 Priority Four - Rare, Near Threatened and other species in need of monitoring:

- (a) Rare. Species that are considered to have been adequately surveyed, or for which sufficient knowledge is available, and that are considered not currently threatened or in need of special protection, but could be if present circumstances change. These species are usually represented on conservation lands.
- (b) Near Threatened. Species that are considered to have been adequately surveyed and that are close to qualifying for Vulnerable, but are not listed as Conservation Dependent.
- (c) Species that have been removed from the list of threatened species during the past five years for reasons other than taxonomy.

Principles for clearing native vegetation:

- (a) Native vegetation should not be cleared if it comprises a high level of biological diversity.
- (b) Native vegetation should not be cleared if it comprises the whole or a part of, or is necessary for the maintenance of, a significant habitat for fauna indigenous to Western Australia.
- (c) Native vegetation should not be cleared if it includes, or is necessary for the continued existence of, rare flora.
- (d) Native vegetation should not be cleared if it comprises the whole or a part of, or is necessary for the maintenance of a threatened ecological community.
- (e) Native vegetation should not be cleared if it is significant as a remnant of native vegetation in an area that has been extensively cleared.
- (f) Native vegetation should not be cleared if it is growing in, or in association with, an environment associated with a watercourse or wetland.
- (g) Native vegetation should not be cleared if the clearing of the vegetation is likely to cause appreciable land degradation.
- (h) Native vegetation should not be cleared if the clearing of the vegetation is likely to have an impact on the environmental values of any adjacent or nearby conservation area.
