On 30 May 2019, BOK converted from a public company to a proprietary company and name changed to Marda Operations Pty Ltd (the same ACN as BOK: ACN 124 374 321). This is the first correction to the clearing permit.</p> <p>Marda Operations Pty Ltd has modified the mine designs to access more gold ore resources than was originally proposed in 2014, as well as changing the project from processing on-site, to now a mining and trucking operation with processing off-site. 	<p>If yes, provide details:</p> <p>The clearing area requested is less than originally granted in CPS 6197/2 by removing the need for a process plant, tailing storage facility, airstrip and accommodation village. The slightly expanded application area to allow for more economic recovery of the resources as well as improving safety of the mining activities has also consciously avoided known locations of Priority flora species in the area. A copy of the flora and vegetation survey reports which supported the original CPS 6197/1 clearing permit application are provided in Attachment 6 (IBSA Data package). Attachment 2 shows the revised clearing permit application area with mapped Priority species to demonstrate avoidance of potential impacts.</p>
