Environmental Protection Act 1986 s 51E

Clearing of native vegetation is prohibited in Western Australia except where a clearing permit has been granted or an exemption applies. A person who causes or allows unauthorised clearing commits an offence.

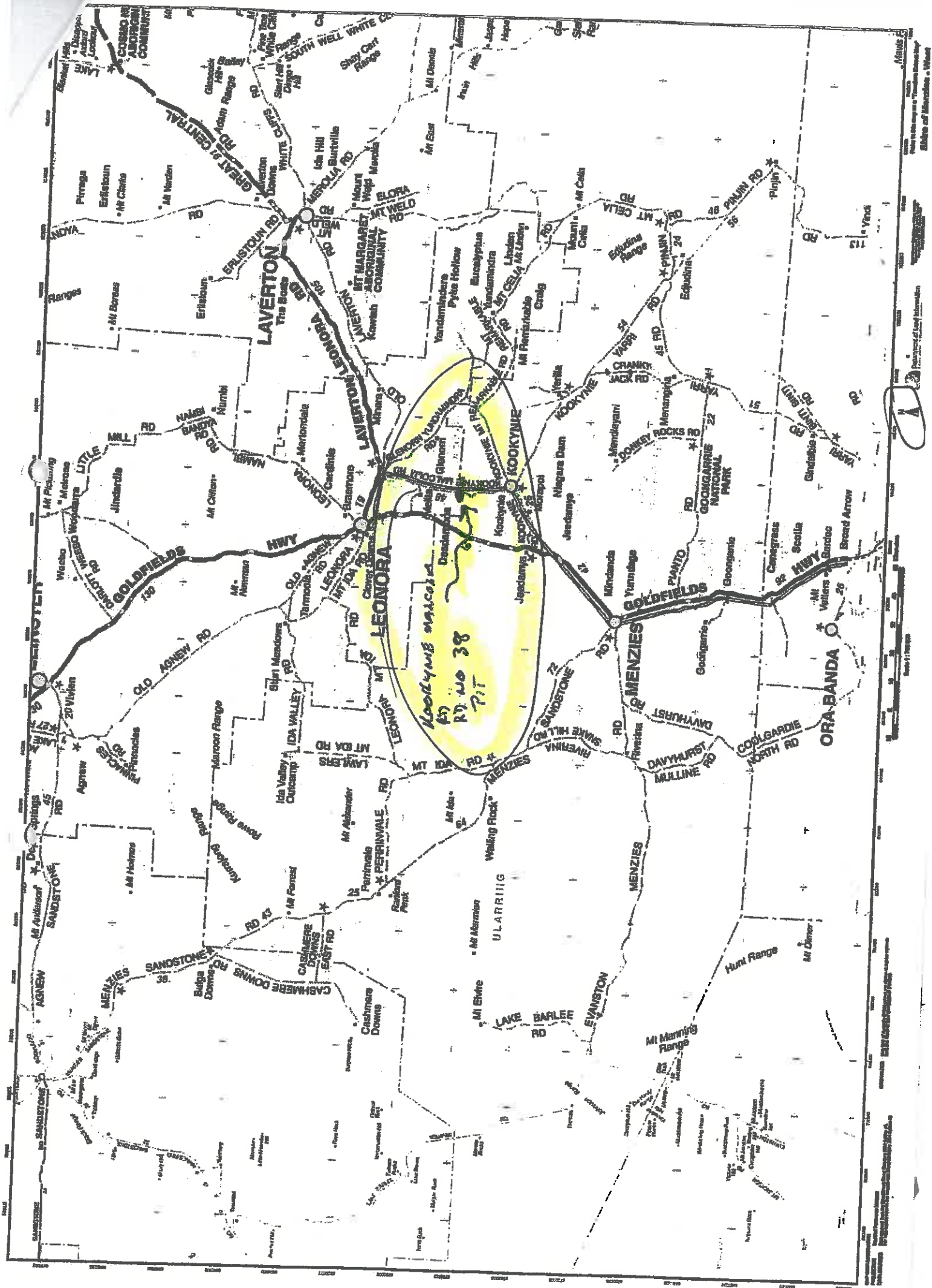
Clearing area of pit 1 extends approx. 100 metres from the existing pit on one side only in a wedge shape
