The increased boundary will incorporate the following Mining Tenements;</p> <ul style="list-style-type: none"> • new Mining Tenement M25/371 in entirety (mining infrastructure) (currently under assessment) • increased area on M25/71 (mining infrastructure); and • a portion of M25/236 (accommodation village). <p>CPS 6457/2 is currently approved for 84 Ha. An additional 136 ha of clearing is required for a total of 220 Ha approved with this NVCP.</p> <p>Clearing will be conducted with mechanised earthmoving equipment (bulldozers, loaders, graders etc) with cleared vegetation and topsoil being salvaged and stockpiled for use in rehabilitation at the close of mining.</p> <p>Clearing is due to commence in August 2021 and will be ongoing during construction of the expanded mining operations and periodically during the life of mine (6 yrs).</p> <p>The final land-use will be concurrent pastoral lease and Class C conservation reserve (Randell Timber Reserve).
