Proposed Project: Felling and Excavation of up to 25 individual trees for the collection of Biomass data to

be used for Scientific-Environmental purposes.

Operational Details of Project:

Auscarbon Pty Ltd is a company which is primarily developing biodiverse environmental vegetation establishments as carbon sequestration sinks. Since 2008, Auscarbon has established approximately 10,000 hectares over 6 properties in the Morawa and Perenjori Shires.

An essential part of a carbon sequestration project is the need to collect actual vegetation data to develop biomass growth models and continuously improve the accuracy of the growth model. Whilst Auscarbon can regularly collect data from its young plantations, there is very little opportunity to collect older age and rotation-end data. This is the primary objective of this project – a one-off program to collect relevant biomass data of larger trees, more representative of the end-of rotation period. The trees will be sampled at a very low intensity from remnant forest areas. The sampling target is 20-25 trees that will sampled within a large area (approximately 157 ha). In most cases the land around the remnant areas have been established with native trees and shrubs as part of Auscarbon's development of carbon sequestration sinks.

In addition to internal use of the data from the project, the data has high level importance as inclusion into the CSIRO's current program of widening the scope of the national biomass database which is behind the Commonwealth Department of Environment biomass model (FullCAM). Auscarbon has entered into a collaborative arrangement with CSIRO Land and Water to provide biomass data of larger-diameter and older trees from lower-rainfall regions. The proposed project has the following operational steps:

- 1. Identify trees of target species and sizes within specified sample zones.
- Record detailed sample location GPS, soil types, topographic position and other environmental information.
- Take photographs and measurements of the standing trees (stem diameter, tree height, and crown dimensions).
- Fell trees and breakdown to weigh 100% of stems, branches and foliage (the above-ground biomass).
- With an excavator or backhoe carefully dig around stump and extract roots. The topsoil will be separated from sub-soil. All extracted roots and stump will be weighed (the below-ground biomass).
- Samples of stemwood, branchwood, foliage and root material will be taken for moisture content and possibly wood density measurement.
- 7. The excavated hole will be filled in (topsoil on top) and sampled debris spread over the site.

NOTE:

No adjacent trees will be sampled.

Trees will be felled with objective of not damaging adjacent trees.

No cleared tracks will be established to trees.




