Application for a clearing permit (area permit) Environmental Protection Act 1986 s 51E **FORM C1**

SCANNED

Clearing of native vegetation is prohibited in Western Australia except where a clearing permit has been granted or an exemption applies. A person who causes or allows unauthorised clearing commits an offence.

Part 1 Assessment bilateral agreement

The native vegetation clearing processes under Part V of the *Environmental Protection Act 1986* (EP Act) have been accredited by the Commonwealth of Australia under the *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act) and can be assessed under an assessment bilateral agreement.

Proposed method of clearing

The vegetation will be cleared with a front end loader (or similar plant) and stockpiled at the Allawuna Landfill facility for disposal. The trees will be cut down using a reciprocating saw and cut into logs and stockpiled for future use.
