Purpose of clearing

The Badjaling Rd provides access to the Badjaling Community settlement and historical Aboriginal sites from the main York-Merredin Rd as well as a grain freight truck route. This road requires a full reconstruction and upgrade for safety purposes.

The Badjaling North Road has been formally closed to enable less of a barrier to the movement of water through the Reserve / Drain and discharge into the salt river system as the Badjaling community is subject to flooding after high rainfall events.

Reconstruction of Badjaling Rd will ensure access to the Badjaling community, improve the
