To push off the existing bush with a dozer, removing 100mm of topsoil and using it to rehabilitate old road reserves.

Purpose of clearing

The purpose of clearing this area is for the new road alignment to tie into Great Eastern Highway, with the proposed realignment of Great Eastern Highway in the near future. This is to elevate the Black Spot corner located on Carrabin South Road and Carrabin Siding Road 3km south of Carrabin townsite.

Part 3 Applicant

To apply for a permit you must either be:

- the landowner;
- acting on the landowner's behalf;

Note: If you are acting on behalf of the landowner, you must attach a letter of authority from the landowner explicitly stating that you, the applicant, has authority to clear on the said land.

Ownership of land

If granted, the permit will be issued in the name of the landowner (or applicant if acting on behalf of the landowner).

A landowner can be:

- a person who holds the Certificate of Title
- a person who is the lessee of Crown land, or
- a public authority that is responsible for care of the land.
