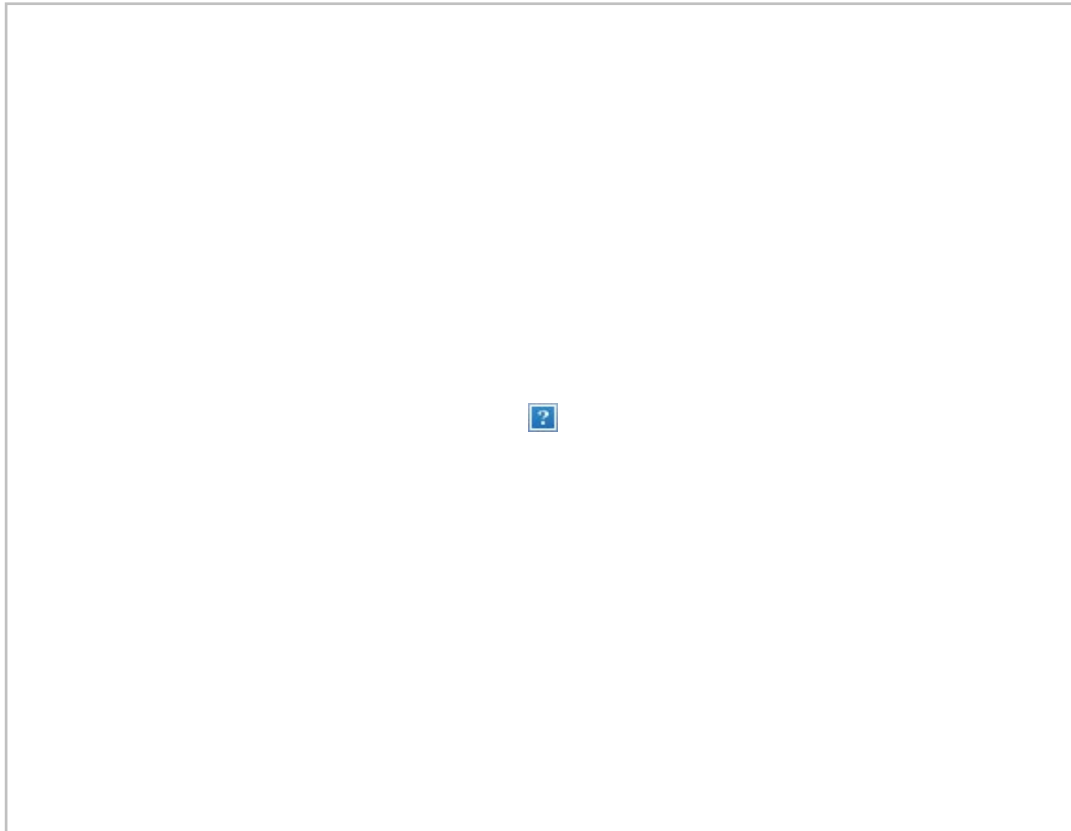


Hi Alicia,
