

Main Roads partially owns the land on which the application occurs. Under the Land Administration Act 1997, Main Roads has the right to compulsorily acquire land required for works associated with the construction of the Muchea North section of GNH. A corridor of land surrounding the alignment will ultimately be acquired by Main Roads from the individual landowners and transferred from freehold land to road reserve. As it is expected that the majority of clearing required will be carried out on land that will ultimately be owned by Main Roads at the time of the clearing, authorisation from individual land owners has not been sought at this time. To this end, no clearing will be undertaken for the purposes of this project until an approved purpose permit is in place and either of the following conditions is met:

- 1. The land in question has been acquired by Main Roads; or
- 2. Written authorisation to clear the land has been obtained from the relevant landowner(s).
