Broad Arrow- Ora Banda Road: A section of land on the Broad Arrow- Ora Banda Road, between map references (51 318768, 6636154 UTM) and (51 314053, 6637734 UTM), omitting a section between (51 317278, 6636510 UTM) and (51317432, 6636511 UTM). A distance of 4.8km (Figure 3). The City of Kalgoorlie-Boulder intends to upgrade this section of Broad-Arrow Ora-Banda Road (from SLK 2.18 to SLK 6.98), from its current gravel surface condition to a bitumen sealed road. Broad-Arrow Ora-Banda Road is a local road within the jurisdiction of the City of Kalgoorlie-Boulder. Clearing will include a 6m wide work zone on either side of the proposed new road cross section along the alignment as per Austroads design standards.
