Mount Monger: A section of land on the Mount Monger Road, between map references: (51 373720, 6585354 UTM) and (3760270, 6583523 UTM). Totalling 3.1Km (Figure 4). The City of Kalgoorlie-Boulder intends to upgrade this section of Mount Monger road (SLK 1.62 to SLK 4.70) from its current gravel surface condition to a bitumen sealed road. The relevant section intersects the Trans Access Road at SLK 4.49. Mount Monger Road and Trans Access Road are all local roads within the jurisdiction of CKB. Clearing will include a 6m wide work zone on either side of the proposed new road cross section along the new alignment as per Austroads design standards (drawing attached).
