	Overall purpose is to construct a concrete walk trail (3 Bays Walkway) over the existing gravel walk trail.					
	Allow vehicle access to the walk trail for delivery of gravel to stabilise the base which can then be used for concrete truck to access the trail segments for laying concrete walk trail.					
	2. Potential for small hand clearing/widening of the trail to allow bobcat or small vehicle access to deliver trail surface materials where required.					
	(eg: removing some excess materials such as gravel and delivery of additional materials where needed for stabilisation and raising areas).					
	3. Potential driving over some small areas of brush (minimal) on northern section (refer to map 3 Bays North QGIS Map V1.2 Proposed Trail)					
	4. Creating new walk trail segment on top of hill (see 3 Bays North QGIS Map V1.2 Proposed Trail) with overburden to be used to rehabilitate the old walk trail near cliff face.					
	Purpose of clearing the 30m x 4m strip (1) is to allow temporary vehicle access to the walk trail shown on the attached maps/aerials (see Clearing Permit - Vehicle Access - Dynamite Bay South) is to construct a concrete walk trail along the existing gravel track (4).					
	Some additional temporary widening may be required along other areas of the trail to allow bobcat and small vehicle access but will be minor and mainly driven over.					
	Any disturbances and clearing will be rehabilitated in its entirety and shall remain undisturbed after the works are completed.					
	Final land use will be a concrete walk trail that should remain undisturbed for 20+ years allowing for full rehabilitation, eliminate need for maintenance of existing trail (gravel) and limit pedestrian traffic to the formal walkway.
