Purpose of clearing

The clearing will be required so that Alinta Energy Transmission (Roy Hill) Pty Ltd (Alinta) can build, own and operate an overhead transmission line from Alinta's existing Roy Hill Substation which will run north approximately 30 kilometres and terminate at Fortescue Metals Group's (FMG) Christmas Creek Substation in the Chichester range of the Pilbara region (the Project).

The Project will supply FMG's Christmas Creek mine site with power to support ongoing mining operations.
