

# **CLEARING PERMIT**

Granted under section 51E of the Environmental Protection Act 1986

**Purpose Permit number:** 8109/2

**Duration of Permit:** From 8 September 2018 to 7 September 2026

**Permit Holder:** Echo Resources Limited

The Permit Holder is authorised to clear native vegetation subject to the following conditions of this Permit.

# PART I - CLEARING AUTHORISED

## 1. Land on which clearing is to be done

Mining Lease 36/146 Mining Lease 36/200

### 2. Clearing authorised (purpose)

The Permit Holder is authorised to clear native vegetation for the purpose of mineral production.

# 3. Area of Clearing




Figure 1: Map of the boundary of the area within which clearing may occur

The Permit Holder must not clear more than 400 hectares of native vegetation within the area cross-hatched yellow in Figure 1 of Schedule 1.

### **PART II - MANAGEMENT CONDITIONS**

# 4. Avoid, minimise and reduce the impacts and extent of clearing

In determining the amount of native vegetation to be cleared under this Permit, the Permit Holder must apply the following principles, set out in descending order of preference:

- (a) avoid the clearing of native vegetation;
- (b) minimise the amount of native vegetation to be cleared; and
- (c) reduce the impact of clearing on any environmental value.

## 5. Weed control

When undertaking any clearing or other activity authorised under this Permit, the Permit Holder must take the following steps to minimise the risk of the introduction and spread of *weeds*:

- (a) clean earth-moving machinery of soil and vegetation prior to entering and leaving the area to be cleared;
- (b) ensure that no known weed-affected soil, mulch, fill or other material is brought into the area to be cleared; and
- (c) restrict the movement of machines and other vehicles to the limits of the areas to be cleared.

# PART III - RECORD KEEPING AND REPORTING

### 6. Records to be kept

The Permit Holder must maintain records relating to the listed relevant matters in accordance with the specifications detailed in Table 1.

### 7. Reporting

- (a) The Permit Holder shall provide a report to the *CEO* by 1 August each year for the life of this Permit, demonstrating adherence to all conditions of this Permit, and setting out the records required under Condition 6 of this Permit in relation to clearing carried out between 1 July and 30 June of the previous financial year.
- (b) If no clearing authorised under this Permit was undertaken between 1 July and 30 June of the previous financial year, a written report confirming that no clearing under this permit has been carried out, must be provided to the *CEO* by 1 August of each year.
- (c) Prior to 7 September 2026, the Permit Holder must provide to the *CEO* a written report of records required under Condition 6 of this Permit where these records have not already been provided under Condition 7(a) or 7(b) of this Permit.

# **Clearing Permit Decision Report**

## 1. Application details and outcomes

### 1.1. Permit application details

# 1.2. Description of clearing activities

Clearing permit CPS 8109/1 was granted by the Department of Mines and Petroleum (now the Department of Mines, Industry Regulation and Safety) on 16 August 2018 and was valid from 8 September 2018 to 7 September 2023. The permit authorised the clearing of up to 200 hectares of native vegetation within a boundary of approximately 1,816 hectares, for the purpose of mineral production.

The Permit Holder applied to amend CPS 8109/1 to increase the amount of clearing authorised to 400 hectares and extend the permit duration to 7 September 2026.

### 1.3. Decision on application and key considerations

**Decision:** Grant

Decision date: 7 July 2022

**Decision area:** 400 hectares of native vegetation

## 1.4. Reasons for decision

This clearing permit application was made in accordance with section 51KA(1) of the *Environmental Protection Act 1986* (EP Act) and was received by the Department of Mines, Industry Regulation and Safety (DMIRS) on 4 December 2021. DMIRS advertised the application for a public comment for a period of 21 days, and no submissions were received.

In making this decision, the Delegated Officer had regard for the site characteristics (Appendix A), relevant datasets (Appendix D), supporting information provided by the applicant including the results of a flora and vegetation survey, the clearing principles set out in Schedule 5 of the EP Act (Appendix B), proposed avoidance and minimisation measures (Section 3.1), relevant planning instruments and any other matters considered relevant to the assessment (Section 3.3).

The assessment has not changed since the assessment for CPS 8109/1. The permit holder has advised that as of 30 June 2021, no clearing has been undertaken under the permit (Northern Star Resources, 2021). The Delegated Officer determined that the proposed additional clearing of 200 hectares within the same permit envelope and extending the permit duration is not likely to lead to an unacceptable risk to environmental values.

# 1.5. Site map




Figure 1. Map of the application area. The yellow area indicates the area within which conditional authorised clearing can occur under the granted clearing permit.

A site map of proposed clearing is provided in Figure 1 below.

# 2. Legislative context

The clearing of native vegetation in Western Australia is regulated under the EP Act and the Environmental Protection (Clearing of Native Vegetation) Regulations 2004 (Clearing Regulations).

In addition to the matters considered in accordance with section 510 of the EP Act (see Section 1.4), the Delegated Officer has also had regard to the objects and principles under section 4A of the EP Act, particularly:

- the precautionary principle
- the principle of intergenerational equity
- the principle of the conservation of biological diversity and ecological integrity.

Other legislation of relevance for this assessment includes:

- Biodiversity Conservation Act 2016 (WA) (BC Act)
- Conservation and Land Management Act 1984 (WA) (CALM Act)
- Mining Act 1978 (WA)

The key guidance documents which inform this assessment are:

- Procedure: Native vegetation clearing permits (DWER, October 2021)

# 3. Detailed assessment of application

### 3.1. Avoidance and mitigation measures

The Delegated Officer was satisfied that the applicant has made a reasonable effort to avoid and minimise potential impacts of the proposed clearing on environmental values.

# 3.2. Assessment of impacts on environmental values

No new biological information has been provided in support of the amendment application. The environmental values of the application area are well understood, and are described in the previous version of the decision report, based on biological studies undertaken by Botanica (2018). The previous assessment of the clearing did not identify any significant environmental impacts from the clearing of 200 hectares. The permit boundary contains a significant amount of area which has been impacted by previous mining activities. The additional area will be focussed on the existing areas of disturbance and will also include some areas of previous rehabilitation. The proposed amendment to clear 400 hectares is not likely to have any significant environmental impacts. Based on the current environmental information, the extension of the permit duration by three years is unlikely to change the environmental impacts of the proposed clearing. The conditions currently imposed on clearing permit CPS 8109/1 are considered adequate to manage the impacts of the clearing.

A review of current environmental information (Appendix A) reveals that the assessment against the clearing principles has not changed significantly from the Clearing Permit Decision Report CPS 8109/1.

## 3.3. Relevant planning instruments and other matters

The clearing permit amendment application was advertised on 14 December 2021 by the Department of Mines, Industry Regulation and Safety inviting submissions from the public. No submissions were received in relation to this application.

There is one native title claim over the area under application (DPLH, 2022). This claim has been registered with the National Native Title Tribunal on behalf of the claimant group. However, the mining tenure has been granted in accordance with the future act regime of the *Native Title Act 1993* and the nature of the act (i.e. the proposed clearing activity) has been provided for in that process, therefore, the granting of a clearing permit is not a future act under the *Native Title Act 1993*.

There are no registered Aboriginal Sites of Significance within the application area (DPLH, 2022). It is the proponent's responsibility to comply with the *Aboriginal Heritage Act 1972* and ensure that no Aboriginal Sites of Significance are damaged through the clearing process.

Other relevant authorisations required for the proposed land use include:

A Mining Proposal / Mine Closure Plan approved under the Mining Act 1978.

It is the proponent's responsibility to liaise with the Department of Water and Environmental Regulation and the Department of Biodiversity, Conservation and Attractions, to determine whether a Works Approval, Water Licence, Bed and Banks Permit, or any other licences or approvals are required for the proposed works.

# Appendix A. Site characteristics

# A.1. Site characteristics

Characteristic	Details		
Local context	The application area is located approximately 54 kilometres northeast of Leinster. The area proposed to be cleared is part of an expansive tract of native vegetation in the extensive land use zone of Western Australia. There is an existing mine within the application area including pits and waste rock dumps (GIS Database).		
Ecological linkage	According to available databases, the application area does not contain any known or mapped ecological linkages.		
Conservation areas	The closest conservation area is the Wanjarri Nature Reserve which is located approximately six kilometres west of the application area at its closest point.		
Vegetation description	The vegetation of the application area is broadly mapped as the following Beard vegetation associations:  18: Low woodland; mulga ( <i>Acacia aneura</i> ); and  107: Hummock grasslands, shrub steppe; mulga and <i>Eucalyptus kingsmillii</i> over hard spinifex (GIS Database).		
	A flora and vegetation survey was conducted over the application area by Botanica Consulting during May, 2018. The following vegetation associations were recorded within the application area (Botanica Consulting, 2018):		
	Clay-Loam Plain CLP-AFW1 - Low woodland of Acacia incurvaneura / A. caesaneura over low scrub of Eremophila forrestii subsp. forrestii / E. margarethae and low hummock/tussock grassland of Triodia desertorum / Eriachne mucronata / Eragrostis eriopoda on clay-loam plain.		
	Sandy-Loam Plain SLP-AFW1 - Low woodland of <i>Acacia caesaneura / A. incurvaneura</i> over mid shrubland of <i>Senna artemisioides</i> subsp. <i>filifolia</i> and low hummock grassland of <i>Triodia desertorum</i> on sandloam plain.		
	SLP-MWS1 - Sparse mallee shrubland of <i>Eucalyptus youngiana</i> over low open shrubland of <i>Acacia ayersiana</i> and low hummock/tussock grassland of <i>Triodia desertorum / Eragrostis eriopoda</i> on sand-loam plain.		
	Rocky Hillslope RH-AFW1 - Low woodland of Acacia incurvaneura / A. pruinocarpa over mid sparse shrubland of Senna artemisioides subsp. helmsii / Scaevola spinescens and low sparse shrubland of Ptilotus obovatus / Maireana georgei on rocky hillslope.		
Vegetation condition	The vegetation survey by Botanica (2018) indicates the vegetation within the proposed clearing area is in very good to completely degraded (Keighery, 1994) condition. There are significant portions of the application area which have been previously cleared for mining activities.		
	The full Keighery (1994) condition rating scale is provided in Appendix C.		
Climate and landform	The application area is mapped at an elevation of 550 metres AHD. The annual average rainfall (Leinster) is 251.6 millimetres (BoM, 2022).		
Soil description	The soils of the application area are broadly mapped as soil type AB14. This soil type is described as gently undulating upland overlying limestone with a few dune formations and some limestone outcrop: chief soils are sands overlying a carbonate pan with some loose calcareous sands in dunes, and shallow loamy soils overlying limestone (Northcote et al., 1960-68).		
Land degradation risk	The application area lies within the Ararak, Bullimore and Desdemona land systems (GIS Database). All of these land systems are generally not prone to erosion (Pringle et al., 1994).		
Waterbodies	The desktop assessment and aerial imagery indicated that there are no watercourses within the application area.		
Hydrogeography	The application area is not within any public drinking water source areas. The mapped groundwater salinity is 500-1,000 milligrams per litre total dissolved solids which is described as marginal (GIS Database).		

Characteristic	Details
Flora	There are records of three species of Priority flora within the local area (surrounding 20 kilometres).
Ecological communities	There are no records of any Threatened or Priority Ecological Communities (TEC/PEC) within the application area (GIS Database). There are no known TECs or PECs within the local area (20 kilometres).
Fauna	There are two records of Malleefowl within the local area (20 kilometre radius).

# Appendix C. Vegetation condition rating scale

Vegetation condition is a rating given to a defined area of vegetation to categorise and rank disturbance related to human activities. The rating refers to the degree of change in the vegetation structure, density and species present in relation to undisturbed vegetation of the same type. The degree of disturbance impacts upon the vegetation's ability to regenerate. Disturbance at a site can be a cumulative effect from a number of interacting disturbance types.

Considering its location, the scale below was used to measure the condition of the vegetation proposed to be cleared. This scale has been extracted from Keighery, B.J. (1994) *Bushland Plant Survey: A Guide to Plant Community Survey for the Community*. Wildflower Society of WA (Inc). Nedlands, Western Australia.

Measuring vegetation condition for the South West and Interzone Botanical Province (Keighery, 1994)

Condition	Description	
Pristine	Pristine or nearly so, no obvious signs of disturbance.	
Excellent	Vegetation structure intact, with disturbance affecting individual species; weeds are non-aggressive species.	
Very good	Vegetation structure altered, with obvious signs of disturbance. For example, disturbance to vegetation structure caused by repeated fires, the presence of some more aggressive weeds, dieback, logging and/or grazing.	
Good	Vegetation structure significantly altered by very obvious signs of multiple disturbances. Retains basic vegetation structure or ability to regenerate it. For example, disturbance to vegetation structure caused by very frequent fires, the presence of some very aggressive weeds at high density, partial clearing, dieback and/or grazing.	
Degraded	Basic vegetation structure severely impacted by disturbance. Scope for regeneration but not to a state approaching good condition without intensive management. For example, disturbance to vegetation structure caused by very frequent fires, the presence of very aggressive weeds, partial clearing, dieback and/or grazing.	
Completely degraded	The structure of the vegetation is no longer intact and the area is completely or almost completely without native species. These areas are often described as 'parkland cleared' with the flora comprising weed or crop species with isolated native trees or shrubs.

# **Definitions:**

{DBCA (2019) Conservation Codes for Western Australian Flora and Fauna. Department of Biodiversity, Conservation and Attractions, Western Australia}:-

### T Threatened species:

Listed by order of the Minister as Threatened in the category of critically endangered, endangered or vulnerable under section 19(1), or is a rediscovered species to be regarded as threatened species under section 26(2) of the *Biodiversity Conservation Act 2016* (BC Act).

**Threatened fauna** is that subset of 'Specially Protected Fauna' listed under schedules 1 to 3 of the Wildlife Conservation (Specially Protected Fauna) Notice 2018 for Threatened Fauna.

**Threatened flora** is that subset of 'Rare Flora' listed under schedules 1 to 3 of the *Wildlife Conservation (Rare Flora) Notice 2018* for Threatened Flora.

The assessment of the conservation status of these species is based on their national extent and ranked according to their level of threat using IUCN Red List categories and criteria as detailed below.

### CR Critically endangered species

Threatened species considered to be "facing an extremely high risk of extinction in the wild in the immediate future, as determined in accordance with criteria set out in the ministerial guidelines".

Listed as critically endangered under section 19(1)(a) of the BC Act in accordance with the criteria set out in section 20 and the ministerial guidelines. Published under schedule 1 of the *Wildlife Conservation (Specially Protected Fauna) Notice 2018* for critically endangered fauna or the *Wildlife Conservation (Rare Flora) Notice 2018* for critically endangered flora.

### **EN** Endangered species

Threatened species considered to be "facing a very high risk of extinction in the wild in the near future, as determined in accordance with criteria set out in the ministerial guidelines".

Listed as endangered under section 19(1)(b) of the BC Act in accordance with the criteria set out in section 21 and the ministerial guidelines. Published under schedule 2 of the *Wildlife Conservation* (Specially Protected Fauna) Notice 2018 for endangered fauna or the *Wildlife Conservation* (Rare Flora) Notice 2018 for endangered flora.

# VU Vulnerable species

Threatened species considered to be "facing a high risk of extinction in the wild in the medium-term future, as determined in accordance with criteria set out in the ministerial guidelines".

Listed as vulnerable under section 19(1)(c) of the BC Act in accordance with the criteria set out in section 22 and the ministerial guidelines. Published under schedule 3 of the *Wildlife Conservation* (Specially Protected Fauna) Notice 2018 for vulnerable fauna or the *Wildlife Conservation* (Rare Flora) Notice 2018 for vulnerable flora.

### **Extinct Species:**

### EX Extinct species

Species where "there is no reasonable doubt that the last member of the species has died", and listing is otherwise in accordance with the ministerial guidelines (section 24 of the BC Act).

Published as presumed extinct under schedule 4 of the Wildlife Conservation (Specially Protected Fauna) Notice 2018 for extinct fauna or the Wildlife Conservation (Rare Flora) Notice 2018 for extinct flora.

### EW Extinct in the wild species

Species that "is known only to survive in cultivation, in captivity or as a naturalised population well outside its past range; and it has not been recorded in its known habitat or expected habitat, at appropriate seasons, anywhere in its past range, despite surveys over a time frame appropriate to its life cycle and form", and listing is otherwise in accordance with the ministerial guidelines (section 25 of the BC Act).

Currently there are no threatened fauna or threatened flora species listed as extinct in the wild. If listing of a species as extinct in the wild occurs, then a schedule will be added to the applicable notice.

### **Specially protected species:**

Listed by order of the Minister as specially protected under section 13(1) of the BC Act. Meeting one or more of the following categories: species of special conservation interest; migratory species; cetaceans; species subject to international agreement; or species otherwise in need of special protection.

Species that are listed as threatened species (critically endangered, endangered or vulnerable) or extinct species under the BC Act cannot also be listed as Specially Protected species.

### MI Migratory species

Fauna that periodically or occasionally visit Australia or an external Territory or the exclusive economic zone; or the species is subject of an international agreement that relates to the protection of migratory species and that binds the Commonwealth; and listing is otherwise in accordance with the ministerial guidelines (section 15 of the BC Act).

Includes birds that are subject to an agreement between the government of Australia and the governments of Japan (JAMBA), China (CAMBA) and The Republic of Korea (ROKAMBA), and fauna subject to the *Convention on the Conservation of Migratory Species of Wild Animals* (Bonn Convention), an environmental treaty under the United Nations Environment Program. Migratory species listed under the BC Act are a subset of the migratory animals, that are known to visit Western Australia, protected under the international agreements or treaties, excluding species that are listed as Threatened species.

Published as migratory birds protected under an international agreement under schedule 5 of the Wildlife Conservation (Specially Protected Fauna) Notice 2018.

## CD Species of special conservation interest (conservation dependent fauna)

Fauna of special conservation need being species dependent on ongoing conservation intervention to prevent it becoming eligible for listing as threatened, and listing is otherwise in accordance with the ministerial guidelines (section 14 of the BC Act).

Published as conservation dependent fauna under schedule 6 of the Wildlife Conservation (Specially Protected Fauna) Notice 2018.

### OS Other specially protected species

Fauna otherwise in need of special protection to ensure their conservation, and listing is otherwise in accordance with the ministerial guidelines (section 18 of the BC Act).

Published as other specially protected fauna under schedule 7 of the Wildlife Conservation (Specially Protected Fauna) Notice 2018.

### P Priority species:

Possibly threatened species that do not meet survey criteria, or are otherwise data deficient, are added to the Priority Fauna or Priority Flora Lists under Priorities 1, 2 or 3. These three categories are ranked in order of priority for survey and evaluation of conservation status so that consideration can be given to their declaration as threatened fauna or flora.

Species that are adequately known, are rare but not threatened, or meet criteria for near threatened, or that have been recently removed from the threatened species or other specially protected fauna lists for other than taxonomic reasons, are placed in Priority 4. These species require regular monitoring.

Assessment of Priority codes is based on the Western Australian distribution of the species, unless the distribution in WA is part of a contiguous population extending into adjacent States, as defined by the known spread of locations.

# P1 Priority One - Poorly-known species

Species that are known from one or a few locations (generally five or less) which are potentially at risk. All occurrences are either: very small; or on lands not managed for conservation, e.g. agricultural or pastoral lands, urban areas, road and rail reserves, gravel reserves and active mineral leases; or

otherwise under threat of habitat destruction or degradation. Species may be included if they are comparatively well known from one or more locations but do not meet adequacy of survey requirements and appear to be under immediate threat from known threatening processes. Such species are in urgent need of further survey.

### P2 Priority Two - Poorly-known species

Species that are known from one or a few locations (generally five or less), some of which are on lands managed primarily for nature conservation, e.g. national parks, conservation parks, nature reserves and other lands with secure tenure being managed for conservation. Species may be included if they are comparatively well known from one or more locations but do not meet adequacy of survey requirements and appear to be under threat from known threatening processes. Such species are in urgent need of further survey.

# P3 Priority Three - Poorly-known species

Species that are known from several locations, and the species does not appear to be under imminent threat, or from few but widespread locations with either large population size or significant remaining areas of apparently suitable habitat, much of it not under imminent threat. Species may be included if they are comparatively well known from several locations but do not meet adequacy of survey requirements and known threatening processes exist that could affect them. Such species are in need of further survey.

## P4 Priority Four - Rare, Near Threatened and other species in need of monitoring

- (a) Rare. Species that are considered to have been adequately surveyed, or for which sufficient knowledge is available, and that are considered not currently threatened or in need of special protection but could be if present circumstances change. These species are usually represented on conservation lands.
- (b) Near Threatened. Species that are considered to have been adequately surveyed and that are close to qualifying for vulnerable but are not listed as Conservation Dependent.
- (c) Species that have been removed from the list of threatened species during the past five years for reasons other than taxonomy.

# Principles for clearing native vegetation:

- (a) Native vegetation should not be cleared if it comprises a high level of biological diversity.
- **(b)** Native vegetation should not be cleared if it comprises the whole or a part of, or is necessary for the maintenance of, a significant habitat for fauna.
- (c) Native vegetation should not be cleared if it includes, or is necessary for the continued existence of, threatened flora.
- (d) Native vegetation should not be cleared if it comprises the whole or a part of, or is necessary for the maintenance of a threatened ecological community.
- (e) Native vegetation should not be cleared if it is significant as a remnant of native vegetation in an area that has been extensively cleared.
- (f) Native vegetation should not be cleared if it is growing in, or in association with, an environment associated with a watercourse or wetland.
- (g) Native vegetation should not be cleared if the clearing of the vegetation is likely to cause appreciable land degradation.
- (h) Native vegetation should not be cleared if the clearing of the vegetation is likely to have an impact on the environmental values of any adjacent or nearby conservation area.
- (i) Native vegetation should not be cleared if the clearing of the vegetation is likely to cause deterioration in the quality of surface or underground water.
- (j) Native vegetation should not be cleared if the clearing of the vegetation is likely to cause, or exacerbate, the incidence or intensity of flooding.
