## Application to amend a clearing permit

*Environmental Protection Act 1986, section 51KA*

### FORM C4

The clearing of native vegetation is prohibited in Western Australia unless a clearing permit has been granted for the clearing or where a permit is not required (either due to a referral determination that one is not needed or because an exemption applies). A person who causes or allows unauthorised clearing commits an offence.

#### Part 1: Assessment bilateral agreement

No native vegetation was cleared in the 2022/2023 reporting period with an allocation of 24.58 ha remaining overall (a total of 2.29 ha has been used between 2018 to 2023).</p> <p>The latest CPS 8293/1 Annual Environmental Report (AER) is provided as Attachment A. This document specifies no disturbance occurred during the 2022/2023 reporting period.</p> <p>The permit requires extension to allow native vegetation clearing for potential future mining activity development, exploration activities and flexibility in making modification to new and existing operational supporting infrastructure. The additional clearing will not exceed the remaining allocation of 24.58 ha under permit CPS 8293/1. This permit underpins Big Bell Gold Operations Pty Ltd (BBGO) approval and compliance programs at the Kinsella mine area situated in the Day Dawn Project.</p> <p>BBGO notes that no request to amend, alter or remove existing conditions of CPS 8293/1 is applied for within this application.</p> <p>Considering CPS 8293/1 is a 'purpose permit', BBGO is seeking a five year extension.</p>
