	The overall development footprint has increased to ensure that the minimum required standard of sporting fields can be accommodated. The increase is due to the fact that the reserve includes a large area of space specifically for the catchment of stormwater from the surrounding area. The requirement to retain this within the existing reserve space has resulted in an expansion to the east of the active reserve space and the clearing footprint.
