<p>Provide details of the proposed change(s), and the rationale for it / them.</p> <p>The City is seeking to part-fund these works with a grant from Department of Transport (DoT) Recreational Boating Facilities Scheme (RBFS). In February 2019, DoT announced changes to the RBFS grant timetable. As a result of these changes the City's project delivery timeline is impacted. Hence, the City is seeking one year extension of the clearing permit from 10 April 2021 to 10 April 2022.</p> <p>The size and boundary of the application area will remain unchanged and therefore, supporting documentation from the original submission still applies.</p>
