	1. Clear isolated paddock trees, mostly dead but no hollows, to fully utilise land for intended pine plantation. These trees will become hazards if left standing and impede operations. 2. Clear small pockets of previously-cleared scrubby vegetation for intended pine and blue gum plantations. Land cleared within last 20 years but uncertain whether carried out under permit; 3. Clear small pocket of remnant vegetation infested with Sydney Golden Wattle (<i>Acacia longifolia</i>) and rapidly degrading. This will also help assist with wattle control program in adjacent healthy native vegetation by removing seed source. Will
